Heritage NSW has reviewed the Albion Park Quarry Extraction Area Stage 7 Extension - Aboriginal Cultural Heritage Assessment Report (ACHAR), Prepared for Cleary Bros (Bombo) Pty Ltd, Report Biosis Pty Ltd, August 2021, with respect to Aboriginal Cultural Heritage (ACH) and make the following comments.

Heritage NSW understands that Biosis Pty Ltd was commissioned by Cleary Bros (Bombo) Pty Ltd to undertake an Aboriginal Cultural Heritage Assessment (ACHA) of a proposed extension of the current extraction area within the Albion Park Quarry, NSW. The development will be assessed under Part 4, Division 4.7 of the Environmental Planning and Assessment Act 1979 (EP&A Act) as a State Significant Development (SSD). The study area is located on private land in the locality of Croom, approximately 20 kilometres south of the Wollongong Central Business District (CBD). The study area incorporates parts of Lot 1 DP858245 and Lot 7 DP3709 and is bounded by Stage 5 and Stage 6 of the current extraction area to the west, and by farmland to the north, east and south.

The following management recommendations were documented in the ACHAR:

- No further archaeological assessment is required due to the entire study area being assessed as having low archaeological potential.
- Should any Aboriginal objects be encountered during works associated with this proposal, works must cease in the vicinity and the find should not be moved until assessed by a qualified archaeologist. If the find is determined to be an Aboriginal object, the archaeologist will provide further recommendations. These may include notifying the Heritage NSW and Aboriginal stakeholders.
- Discovery of Aboriginal ancestral remains If any suspected human remains are discovered during any activity you must: 1. Immediately cease all work at that location and not further move or disturb the remains. 2. Notify the NSW Police and Heritage NSW's Environmental Line on 131 555 as soon as practicable and provide details of the remains and their location. 3. Not recommence work at that location unless authorised in writing by Heritage NSW.
- Continued consultation with the registered Aboriginal stakeholders as per the
  consultation requirements, it is recommended that the proponent provides a
  copy of this final report to the Aboriginal stakeholders and considers all
  comments received. The proponent should continue to inform these groups
  about the management of Aboriginal cultural heritage sites within the study
  area throughout the life of the Project.

Heritage NSW concurs with all the recommendations documented in the EIS, as such, Heritage NSW does not require further consultation respect to this proposal
