Dear Nahid,

Thank you for your referral dated 22 June 2022 in relation to Environmental Impact Statement (EIS) for the Minarah College. Heritage NSW has reviewed the EIS with respect to Aboriginal Cultural Heritage (ACH) and notes the following.

Heritage NSW has reviewed Appendix Y - Aboriginal Cultural Heritage Assessment Report (ACHAR). Proposed Development at Minarah College, 268 to 278 Catherine Fields Road, Catherine Field, Midson Group Pty Ltd, Tocomwall Pty Ltd, April 2022. Heritage NSW understands that a site inspection and archaeological survey was carried out on the 22 September 2021, and that it was determined that there are locations that had the potential to retain Aboriginal objects in undisturbed soil profiles. I note that a test excavation program was undertaken, and two Aboriginal objects were identified. The ACHAR recommends the objects be reburied on site, and/or to be managed under a Care Agreement issued by Heritage NSW, before the works proceed. Heritage NSW concurs with this recommendation. Heritage NSW has no additional comments or concerns with respect to ACH and this proposal proceeding.
