

<p><b>STATE ROADS ACT 1986</b></p> <p><b>ORDER - SECTIONS 4 AND 58</b></p> <p><b>DECLARATION AS PUBLIC ROAD OF LAND</b></p> <p><b>AT MARULAN</b></p> <p><b>IN THE SHIRE OF MULWAREE</b></p> <p><b>AND</b></p> <p><b>DECLARATION AS CONTROLLED ACCESS ROAD</b></p> <p><b>OF PART OF THE HUME HIGHWAY - MARULAN BY-PASS</b></p> <p><b>52.9 KM TO 59.22 KM SOUTH OF MITTAGONG</b></p> <p><b>IN THE SHIRE OF MULWAREE</b></p>
<p>I, the Minister for Transport, pursuant to Sections 4 and 58 of the State Roads Act 1986, by this Order -</p> <ol style="list-style-type: none"><li>1. declare as Public Road the land described in Schedules 1 and 2 under;</li><li>2. place the said Public Road described in Schedules 1 and 2, under the care control and management of the Council of the Shire of Mulwaree;</li><li>3. declare as a Main Road the said Public Road described in Schedule 2 and the Public Road described in Schedule 3 under;</li><li>4. declare as a Controlled Access Road the said Main Road described in Schedules 2 and 3;</li><li>5. declare that access to the said Controlled Access Road is restricted, and</li><li>6. specify in Schedule 4 under, the means of access by which a person may enter or leave the said Controlled Access Road.</li></ol> <p><b>B.
