Hi Susanna,

Heritage NSW has reviewed the relevant Aboriginal cultural heritage information supplied in support for the Aspect Industrial Estate, Modification 3 (SSD-10448), and make the following comments.

I note that proposed modification will not result in any additional archaeological impacts to those already approved under the site preparation works and excavation works (SSD-10448). As such, the Mod 3 proposal will not result in any additional Aboriginal cultural heritage impacts. I also note that the Aboriginal Cultural Heritage Assessment Report (ACHAR) initially prepared for those early works, that was prepared in consultation with registered Aboriginal parties, recommended a range of mitigation measures, that are adequate with respected to any potential constraints that may be associated with the proposed modification. Based on this assessment, I am satisfied that an updated ACHAR is not required for MOD 3. Please contact me directly should you require any additional information.
