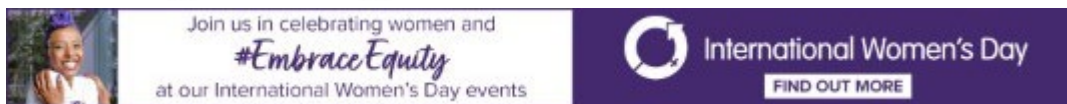
Council has a concern regarding potential glare caused from the increased building height, to the Magdala Park.
