Attachment 1

Plans

- Provide a final stockpile plan that clearly shows all stockpiles and demonstrates accessibility to SB8.
- Provide a swept path of the longest vehicle that would access SB8-SB11.
- Show on the Internal Floor Plan where non-conforming waste would be stored.
- Update the site plans/waste matrix to include municipal waste, commercial waste, slag, leachate, groundwater, fly ash, grit and crushed glass.
- Provide an architectural drawing of the noise wall.
- Please specify which plan shows the lab as it is not labelled.

Waste

- The RTS states that concrete and sand are products not wastes, yet these are not listed separately from the wastes accepted. Have they been included in the 100,000 tonnes of GSW proposed to be accepted?
- Table 15-3 shows the development would accept 7,000 tonnes of commercial and municipal waste, which would not be sorted, yet only 550 tonnes of RRF goes out – how does the commercial and municipal waste fit into the OUT table?
- The development would only accept 100,000 tonnes of solid waste, yet table 2-4-2 (p 68 of the October RTS) shows that 100,000 tonnes of C&D waste would be accepted. Where does other solid waste fit in? if the 100 000 tonnes of solid waste to be accepted is all C&D waste, what about the other wastes?
- Table 15-3 of the October RTS shows 70,000 tonnes of ENM would leave the site whereas the site would only accept 3,000 tonnes of VENM and 6,000 tpa of soil/sand, please clarify.
- Table 2-4-1 shows the concrete waste stream would be 33, 750 tonnes annually, yet table 15-3 shows concrete wastes to be accepted would be 12,000 tpa. Please clarify.
- Show where any waste sorting is undertaken.
- Provide a list of “resources” to be accepted for the concrete batching facility.

Please provide a vehicle breakdown by hour to demonstrate operational peaks have been assessed
