1. Progressive rehabilitation

The Department requests clarification regarding the total areas of progressive rehabilitation to be undertaken in each stage of the Project (including both active rehabilitation and maintenance) as outlined in Sections 4.5.1 to 4.5.5 of the EIS. There appear to be some inconsistencies in the total areas of active rehabilitation and maintenance both within and between Stages 1 to 5. Please provide a simplified table which indicates how the total areas of active rehabilitation and maintenance identified in these sections have been calculated.

2. Road Sales Stockpiling Area

Section 4.4.7 of the EIS indicates that up to 50,000 tonnes of limestone aggregates/sand would be stored at the road sales stockpiling area per year. This appears to conflict with Table 4.2 of the EIS, which indicates that up to 105,000 tonnes of limestone/aggregates would be stored at the road sales stockpiling area. The Department requests clarification in this regard.

3. Schedule of Land

The Department has reviewed the Schedule of Land provided by Boral for inclusion in Appendix 1 of the draft conditions. The Department would appreciate your confirmation that the Schedule provided includes any Crown land and/or public road reserves which form part of the Project. For clarity, it may be preferable to add an additional column which identifies the tenure (ie freehold/leasehold) and landowner of each lot.

4. Figures

The Department requests that you provide high resolution copies of the following figures in JPEG format:

- Figure 2.1 of the EIS – Regional context, with a label identifying the Hume Highway interchange;
- Figure 3.7 of the EIS – Existing planning context;
- Figure 2.7 of the EIS – Conceptual groundwater model domain;
- Figure 2.9 of the EIS – Land ownership, with a label identifying the location of the Aglime facility;
- Figures 4.10 and 4.11 of the EIS – Project layout plans (see Appendix 2 in the Department's draft conditions);
- Figures 4.21 and 4.23 of the EIS (see Appendix 6 in the Department's draft conditions);
- Figure 4.24 of the EIS – Pit cross section A-A;
- Figure 2-3 of the Air Quality Impact Assessment – Representative view of topography;
- Figures D-7 and D-8 of the Air Quality Impact Assessment – cumulative annual PM_{2.5} and PM₁₀ predictions in Stage 1, combined onto one A4 page;
