

Philip,

Happy New Year, I trust you're keeping safe and well.

I spoke with Tony this morning, I may not have articulated clearly what we're seeking endorsement for from Council.

Attached is a plan with a methodology identifying how we'd like to cut and fill the Dam works progressively to maintain the full dam volume at all times.

The current SSD condition requires the cut works in grey hatched area to be fully complete before the area in blue is filled, however this makes it more complicated than it needs to be. If we place the material as we cut it, then the dam volume always remains the same (actually increases during the works as we need to overcut the area in blue before we can start filling due to geotechnical requirements with the existing marsh/soft ground).

DPI&E have given us until Monday 31st January to obtain Council's endorsement on this to close out the RFI for the SSD Mod (letter attached).

I am happy to arrange another site inspection or Teams meeting for next week to run through this if required.

Appreciate your time to review and consider this.



Phil,

Per our chat last week please find attached markup of area we'd like to stockpile some fill material (marked in red) in anticipation of approval down the track to fill the northern end of the site known as "warehouse 7 pad", which is the area impacted by the Regional Basin flood volume (shown in blue in the attached).


We're starting to run out of room on site and want to stockpile (but not final place/compact) material to assist with materials handling on site. We would delineate the flood affected zone on site to ensure filling does not encroach on the flood affected area, and will also ensure commensurate sediment controls are in place around the stockpiles also.

The SSD prevents any earthworks on warehouse pad 7 prior to completing the Regional Basin works, however we are not proposing to undertake any permanent earthworks associated with the new levels, only temporary stockpiling of material.

I appreciate your assistance with considering our proposal.
