#### **Decision**

The Director, Social and Infrastructure Assessments under delegation from the Minister for Planning and Public Spaces has, under section 4.38 of the *Environmental Planning and Assessment Act 1979* (**the Act**) granted consent to the development application subject to conditions.

#### Reasons for decision

The following matters were taken into consideration in making this decision:

- the relevant matters listed in section 4.15 of the Act and the additional matters listed in the statutory context section of the Department's Assessment Report;
- the prescribed matters under the Environmental Planning and Assessment Regulation 2000;
- the objects of the Act;
- all information submitted to the Department during the assessment of the development application and any additional information considered in the Department's Assessment Report;
- the findings and recommendations in the Department's Assessment Report; and
- the views of the community about the project (see Attachment 1).

The findings and recommendations set out in the Department's Assessment Report were accepted and adopted as the reasons for making this decision.

The key reasons for granting consent to the development application are as follows:

- the proposal would provide a range of benefits for the region and the state as a whole, including improved educational facilities, 336 construction jobs, 48 operational jobs and \$45.57 million capital investment;
- the proposal is permissible with development consent, and is consistent with NSW Government policies including the:
  - State Infrastructure Strategy 2018 2038 Building the Momentum;
  - Future Transport Strategy 2056; and
  - South East Tablelands Regional Plan 2036.
- the impacts on the community and the environment can be appropriately minimised, managed or offset to an
  acceptable level, in accordance with applicable NSW Government policies and standards. The consent
  authority has imposed conditions relating to implementation of a School Transport Plan including sustainable
  transport measures, stormwater management, tree protection, and management of construction impacts
  including traffic, parking, noise and dust;
- the issues raised by the community during consultation and in submissions have been considered and adequately addressed through changes to the project and the conditions of consent.
- weighing all relevant considerations, the project is in the public interest.

### Attachment 1 - Consideration of Community Views

The Department exhibited the Environmental Impact Statement (EIS) for the proposal from 17 June until 14 July 2021 (28 days) and received 12 submissions, including five from NSW Government agencies, one from local council, and six were from members of the public.

Of the public submissions, three were in support of the proposal and three submissions provided comments. Council objected to the development.

The Applicant's Response to Submissions (RtS) was exhibited for a period of 14 days, from 12 October until 25 October 2021. The Department received a total of 11 submissions, comprising four submissions from public authorities, a submission from Council and six submissions from the community. Of the community submissions received, two provided comments and four submissions were in objection to the proposal.

The Applicant's Supplementary Response to Submissions (SRtS) was referred to Council. This was referred to Council which subsequently withdrew its objection.

The key issues raised by the community (including in submissions) and considered in the Department's Assessment Report and by the decision maker include traffic, transport and parking, and built form and urban design. Other issues are addressed in detail in the Department's Assessment Report.
