## 2. INTRODUCTION

This Engagement Outcomes Report accompanies an Environmental Impact Statement (EIS) in support of State Significant Development Application (SSD-10352) for new college buildings on the existing campus of Moriah College, Queens Park (the site). The site is legally described as 101 York Road, Queens Park/ Lot 22 DP 879582, 1 Queens Park Road, Queens Park/ Lot 1 DP 701512 and 3 Queens Park Road, Queens Park/ Lot 3 DP 701512.

The proposal seeks consent for:

- Staged demolition of existing buildings A, B, C, D, J, E and removal of demountable buildings S, D, Z.
- Staged construction of new college buildings.
- Phase 1 Construction of a part 3 and part 4 storey STEAM building containing:
  - science, technology, engineering, art and maths rooms
  - technology and applied science rooms
  - administration offices
  - canteen and cafe
  - independent learning centre (library)
  - meeting rooms and auditorium
  - enhanced pedestrian entry at Gate 3A off Baronga Ave
  - basement parking for staff, waste management and storage rooms
  - modified vehicular circulation internal to the site
  - Redesign of the York Road Gate 4 parking area to create improved circulation and on-site staff parking
- Phase 2 Construction of a 3 storey Early Learning Centre (ELC) building and administration offices.
- Student population increase from 1680 students on the site to 1970 students across ELC, primary and high school.
- Modification to internal traffic and parking on the site.
- Active and passive landscape upgrades to the site.
- Removal of trees.

This engagement and communication outcomes report documents the engagement and communications process, community feedback received and considerations in response to feedback undertaken for Moriah College during June-September 2019.

## 3. OVERVIEW OF PROPOSAL

Moriah College is an independent Jewish school established in 1943. The College has operated from the Queens Park Campus (Campus) since 1994 and currently accommodates students across Preschool, Primary and High School educational levels.

The Campus currently contains 18 buildings, ranging in height from one to three storeys, housing a range of facilities. There are three existing vehicle entry / egress points, on York Road and Queens Park Road, and a pedestrian only entry / egress point on Baronga Avenue.

The proposal will involve the redevelopment of various outdated buildings throughout the Campus on the lots: 3 Queens Park Road and 101 York Road, Queens Park. There are no proposed works within 1 Queens Park Road, Queens Park.

The works proposed by Moriah College seek to achieve the following outcomes within a heavily constrained site:

- Replacing of dated and inefficient buildings with new, modern facilities and spaces that are aligned with contemporary standards and teaching methodologies.
- Provision of a new Science, Technology, Engineering, Arts and Mathematics (STEAM) facilities and an Independent Learning Centre (ILC) for the High School.
- Create a new 'front door' for the Queens Park Campus on Baronga Avenue.
- Enhance the existing Early Learning Centre (ELC).
- Increase open, green space for high school students to allow for greater social interaction and enhance collaborative knowledge sharing.
- Meet the future needs of a growing population by providing capacity for an additional 290 (approximate) students from ELC through to high school over the next 10-15 years.
- Address vehicle circulation around Moriah College by consolidating staff and visitor parking and reorienting access away from residential areas on Queens Park Road.


The College can accommodate up to 1680 students from ELC through to high school and is reaching capacity. Moriah College has embarked on a master planning process to address their educational needs for the coming decades.

The application will seek a 17% increase in numbers across the three streams to satisfy demands over 10-15 years.

Primary and high school numbers are currently capped at 1600, with a 15% growth of students sought to extend capacity to 1840. The ELC can currently accommodate 80 enrolments, with future accommodation sought for 130 enrolments.

The current campus total cap on enrolments is 1680 with the future enrolments sought being capped at 1970 enrolments.

- Create pathways for stakeholder interaction and feedback that are open and transparent
- Document key feedback to inform ongoing design and planning
- Understand community views to inform the SSDA for Moriah College

## 6. OVERVIEW OF ENGAGEMENT ACTIVITIES

Community and stakeholder engagement activities were undertaken between June-September 2019. These are outlined below, and feedback is summarised in Section 7 of this report:

#### 6.1.1. College-Community letter

A letter for parents, students and staff was prepared to outline key features of the proposal and invite members of the community to contribute their feedback regarding the proposed masterplan. The letter provided details of feedback mechanisms for Urbis Engagement to obtain more information.

The letter was distributed by Moriah College on 19 June 2019 to parents and teachers.

A copy of this letter is found in Appendix A of this report.

A detailed summary of feedback received has been outlined in Section 8 of this report.

#### 6.1.2. Near neighbour letterbox drop

Urbis Engagement undertook a letterbox drop to near neighbours and border properties to deliver a letter explaining the proposal and how to utilise the dedicated feedback channels. This was an opportunity for near neighbours to be provided information, answer questions and collect feedback.

One letter was distributed to 150 properties on Queens Park Road, Queens Park on 27 June 2019 by Urbis Engagement.

A detailed summary of feedback has been outlined in Section 8 of this report.

A copy of the letter and catchment area it was distributed is found in Appendix B and C of this report respectively.

#### 6.1.3. Fact sheet

A fact sheet was prepared to outline key features of the proposal and invite members of the community to contribute their ideas and thoughts. The fact sheet also invited stakeholders to a community information session.

A fact sheet was distributed to the mailboxes of approximately 500 households across Queens Park Road, Arnold Street, Bourke Street, York Road, Lynch Avenue, Alt Lane, Cuthbert Street, Newland Lane, Manning Street and Bourke Lane, Queens Park on 12 September 2019 by Urbis Engagement. One email was received asking for more information after the letterbox drop.

A detailed summary of feedback has been outlined in Section 8 of this report.

A copy of the fact sheet can be found in Appendix D and a copy of the catchment area for the fact sheet is found in Appendix E of this report.

#### 6.1.4. Website

As part of the consultation process, and to ensure access to specialised information regarding the proposal was readily available, a dedicated project website was developed.

Located at <u>https://urbisgraphics.wixsite.com/moriahmasterplan</u>, the Moriah College Masterplan website provided information about the proposed development application, the planning process and contact details to obtain more information.

The project website will remain open until the SSDA is determined, to keep stakeholders informed.

#### 6.1.5. Media

On 21 June 2019, a media release was distributed regarding the Moriah College SEARs request by Urbis Engagement. This media release was provided to identified stakeholders, with associated press articles being published in local media.

A copy of the media release is provided in Appendix F.

#### 6.1.6. Stakeholder briefings

A briefing request was sent to identified stakeholders offering the opportunity to meet with members of the project team and learn more about the proposal. The feedback obtained in these briefings outlined an interest in student capacity, traffic and access.

The following stakeholders were invited to meet for a face to face briefing:

- Member for Coogee, Dr Marjorie O'Neil.
- Member for Vaucluse, Hon. Gabrielle Upton.
- Moriah Community Consultative Committee.
- Waverly Council elected representatives.
- Queens Park Precinct Group.

At the time of writing this report both the State representatives, Waverley Council elected representatives and the Moriah Community Consultative Committee declined the offer for a briefing.

A one-hour briefing was held with two members of the Queens Park Precinct Committee on 18 June 2019. The Queens Park Precinct Committee are a local resident group who advocate for and update Council regarding issues in the Queens Park area. Feedback at the briefing was neutral with questions received regarding the increase in college numbers and the design of the proposed building.

A detailed summary of feedback has been outlined in Section 8 of this report.

#### 6.1.7. Engagement email and phone line

Members of the public were invited to contact Urbis Engagement through a dedicated 1800 phone number and/or an email address for the duration of the engagement period. At the time of writing this report 10 people have phoned or emailed to provide feedback and/or seek further information during the period of June-September 2019.

A detailed summary of feedback has been outlined in Section 8 of this report.

#### 6.1.8 Community Information Session

A two-hour information session was held on 19 September 2019 at Moriah College after providing an invitation to 500 homes via a letterbox drop. Two community members attended the session, providing a 0.4% attendance rate after the letterbox drop.

The focus of the discussions was traffic, college student numbers and design of the building. One feedback form was received.

A copy of the feedback form provided at the information session can be found in Appendix G.

Information boards outlining key project facts were displayed at the information sessions and are provided in Appendix H.

A detailed summary of feedback has been outlined in Section 8 of this report.

## 7. ENGAGEMENT FEEDBACK

Overall, the stakeholder feedback collected across various channels was mixed regarding community sentiment, knowledge of the Moriah College Masterplan and the anticipated impact of the proposed development. In total 10 pieces of feedback have been received from local residents, predominately via email.

Overall there was a low level of interest from stakeholders regarding the consultation process, however informal communications have been distributed from the Queens Park Precinct Group to local residents encouraging opposition to the proposal.

#### 7.1. KEY THEMES

Key themes which emerged from the feedback included the following:

#### **Overall observations**

- Frustration from those who provided feedback regarding limited traffic and parking in surrounding streets for residents, although this is not specifically related to the Moriah College.
- General queries about the planning process including the approval pathway, timeframes and staging of construction.
- Concern regarding the proposed increase in student numbers.

Stakeholders primary feedback related to local traffic. We note there are many factors that contribute to local traffic volume, such as recent residential developments and toll avoidance routes.

No comments were received regarding environmental and heritage factors; however, these were addressed in communications to the public.

#### Traffic, parking and access

- Residents noted concern that the increase in proposed college capacity may increase traffic during peak periods.
- Questions were received regarding traffic on York Road, Queens Park and if it can be redirected around the College site.
- Questions were received regarding Moriah College's green travel policy and how students are
  encouraged to walk or use public transport to reduce traffic impacts in Queens Park.

#### Noise

• Queries were received regarding how potential noise will be managed both in the construction and operational phase.

#### Design

• Positive and neutral feedback was received regarding the design of the proposal.

#### **Community Access**

• Queries were received about the possibility of the new facilities being made available to general public.


