CEMP is reading very nicely. I've also scanned over the groundwater plan (Rev D). Here are my final comments:

## **Groundwater Plan (Rev D):**

8.1.5.1 – Action Levels need to be checked. VOC still read as 10ppm not 1ppm. Pls amend

8.1.5.2 – Gas readings during excavation should be consistent with CEMP procedures. Still reads as 2x daily minimum. Pls amend

### **CEMP (Rev D):**

Scope of works is clearly outlined although it does not specify that piling works are excluded. Provided the certifier is happy with this I'm ok with it.

2.1.2 -EPA do not need to endorse CEMP unless this was a requirement under the consent??

Table 2.4 – waste classification report may apply to imported materials if recycled wastes such as aggregates etc. are to be used. Pls amend

3.7.7.4 – Reporting on HGG should include Site Auditor Please amend

Drawing S5 sediment fencing around stockpiles dies not align with the direction of water flow and sediment basins shown in Drawing S1 Pls amend as required.

Subject to the above minor edits and any comments that may be provided by the Site Auditor I am satisfied that the Groundwater Management Plan and CEMP are acceptable for the proposed scope of works as defined within the documents. Pls forward a copy of the finalised Groundwater Management Plan and CEMP when available.
