#### Decision

## Date of decision

#### **Reasons for decision**

The following matters were taken into consideration in making this decision:

- the relevant matters listed in section 4.15 of the Act and the additional matters listed in the statutory context section of the Department of Planning, Industry and Environment's (the Department) Assessment Report;
- the prescribed matters under the Environmental Planning and Assessment Regulation 2000;
- the objects of the Act;
- all information submitted to the Department during the assessment of the development application; and
- the views of the community about the project (see Attachment 1).

The findings and recommendations set out in the Department's Assessment Report were accepted and adopted as the reasons for making this decision Additional reasons for making the decision are also recorded in the Department's Assessment Report.

The key reasons for granting consent to the development application are as follows:

- the project would provide a range of benefits for the region and the state as a whole, including specialised educational services which result in the creation of 12 additional jobs and a CIV of \$490,784;
- the project is permissible with development consent, and is consistent with NSW Government policies including:
  - NSW State Priorities
  - State Infrastructure Strategy 2018-2038; and
  - Hunter Regional Plan 2036.
- the impacts on the community and the environment, including traffic and access and parking, landscaping, tree removal and built form and environmental amenity have been can be appropriately minimised, managed or offset to an acceptable level, in accordance with applicable NSW Government policies and standards. The consent authority has imposed conditions to manage impacts in relation to potential construction and operational impacts;
- the issues raised by the community during consultation and in submissions have been considered and adequately addressed through changes to the project and the recommended conditions of consent; and
- weighing all relevant considerations, the project is in the public interest.

## Attachment 1 – Consideration of Community Views

The Department exhibited the Environmental Impact Statement for the project from 15 June 2020 until 13 July 2020 (28 days) and received 12 submissions, including one comment from Council, three individual objections, two individual comments and one in support of the project.

The Department also undertook and inspection of the site.

The key issues raised by the community (including in submissions) and considered in the Department's Assessment Report and by the decision maker including traffic, access and parking, built form, landscaping and tree removal, and environmental amenity. Other issues are addressed in detail in the Department's Assessment Report.
