


image above: Proposed Site Plan

#### 1. Background

- 1.1. ARINA has been commissioned on behalf of St Patricks College to prepare an Accessibility Report to meet the requirements of the Planning Secretary's Environmental Assessment Requirements under Section 4.12(8) of the Environmental Planning and Assessment Act 1979 Schedule 2 of the Environmental Planning and Assessment Regulation 2000.
- 1.2. ARINA has prepared DDA Action Plans, Access Plans and Access Improvement plans for educational institutions and government over a period of 30 years. We regularly provide advice on access and disability matters relating to built facilities for clients in the education sector, including K-12, VET and Higher Education.

## 2. Summary of Understanding

- 2.1. The proposed new building for the College is described in the drawings prepared by BVN and listed at Appendix A.
- 2.2. The proposed building either complies with the NCC in relation to provisions at Section D for Access and Egress or can be made to comply with minor design changes.
- 2.3. Provisions required to comply with AS 1428.1 under the NCC either comply or can be made to comply with minor design changes.
- 2.4. In our opinion, the proposed building can be operated by the School in a way which will comply with the requirements of the Disability Discrimination Act (DDA) 1992 and the Disability Standards for Education made under the DDA.
- 2.5. The quality of access provisions incorporated in the new building is regarded as exemplary, with the provision of two lifts within the building to provide access during and after normal operational hours. There are no internal or external ramps required to provide access for people with a disability.
- 2.6. There is nothing in the design of the building to prevent the FF and E and AV system being delivered to a standard adequate to meet the requirements of the DDA and the Disability Standards for Education.

### 3. Key Observations from the Review

- 3.1. The proposed new building for the College is described in the drawings prepared by BVN and listed at Appendix A.
- 3.2. Sufficient accessible parking spaces are available in the basement (undercover) or at other locations on the campus.
- 3.3. Drop off and pick up for people with a disability is available for access taxis and private vehicles in the adjacent external carpark or in the Basement. From either locations, there is a complying accessible path of travel to all areas of the building. The tiered seating will be provided with three accessible seating spaces in accordance with D3.9.
- 3.4. The building is connected to the existing accessible path of travel which connects to existing facilities, including the playing surface of the adjacent oval. The compliance of existing facilities is not considered in this report.
