Mirvac is looking to prepare an updated staging plan for AIE following determination of MOD 2. Condition A10 requires that the staging plan shall be prepared in consultation with Council, utility and service providers.

The original Staging plan documentation noted attempts at engagement with these authorities, but no direct feedback was provided in response.

Given that the staging plan is not changing much – just to reflect the slightly realigned lot boundaries, to update the timeframes for works commenced to date and to provide more clarity on anticipated future stages now that they are under assessment – is there a need to re-engage with authorities on this matter? We don't anticipate that they will have any feedback, consistent with the first round.

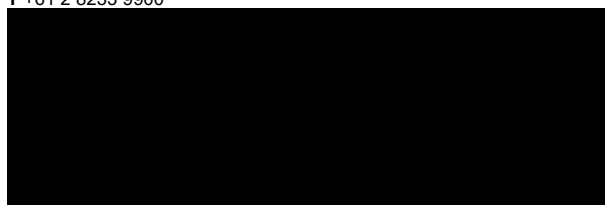
