I refer to your recent correspondence regarding the Woolworths Customer Fulfilment Centre (CFC) and Warehouse at Marrickville (SSD-10468). I understand you are seeking the Planning Secretary's approval to stage the submission of the development's construction-related management plans, and the subsequent agreement of the Planning Secretary to submit the Stage 1 management plans without consultation being undertaken with the relevant public authorities.

Staged submission of the development's construction-related plans (Condition A12)

I understand you intend to split construction of the development into four stages (see Attachment A).

As part of this arrangement, I understand you are also proposing to split submission of the development's construction-related management plans to align with these staging arrangements.

The Department of Planning and Environment (the Department) agrees to the staged submission of the development's construction-related management plans, pursuant to condition A12 of the development consent and in accordance with the staging arrangements outlined in your letter dated 19 September 2022.

Please be reminded that you will need to submit each set of construction-related management plans to the Planning Secretary for approval and, in the case of stages 2 to 4 of the construction works, at least one month prior to the commencement of construction of the stage to which those plans relate.

## Waiving of consultation requirements for the Stage 1 construction-related plans (Condition A13).

I understand you are subsequently seeking the Planning Secretary's agreement to waive the consultation requirements for the Stage 1 construction-related management plans, pursuant to condition A13 of the development consent.

Based on your letter dated 19 September 2022, I note that the Stage 1 works would be limited to the demolition of existing on-site structures, and approximately 16 staff would be present on the site at any one time.

The Department has reviewed your request and agrees to waive the consultation requirements for the Stage 1 construction-related plans, pursuant to condition A13 of the development consent. Please be reminded that you will need to consult with the relevant public authorities during the preparation of the construction-related management plans for all other stages.
