AW Edwards Pty Limited have been appointed Principal Contractor for the purpose of construction of the Hastings Secondary College PCYC – Multi Sport Centre stage 3 of the staging report.

As an authorised representative of AW Edwards Pty Limited. I inform of an amendment to the total quantity of excavation material as stated within the approved Construction and Demolition Waste Management Plan dated 21/04/2021 Revision F prepared by Elephant Foot Recycling Solutions.

The overall reduction of excavated material is associated with the deletion of basement carparking and the introduction of on grade carparking positioned east of the building.

A comparison between the approved and modified demolition waste calculation is shown below.
