The proposed OSD at Site C comprises a 7-storey commercial building above 2-storeys of the Crows Nest Station entry (approved under CSSI). The building consists of a total GFA of 3,100sqm, maximum height of RL 127m (with an additional 5m building services zone for rooftop plan and services), building entrance at ground level, bicycle parking and EoT at level 1, commercial offices on levels 2-8, accessible garden on level 9, associated building landscaping and signage zones.
