Thank you for the ongoing consultation and opportunity to comment on the redevelopment of the Telopea Precinct.

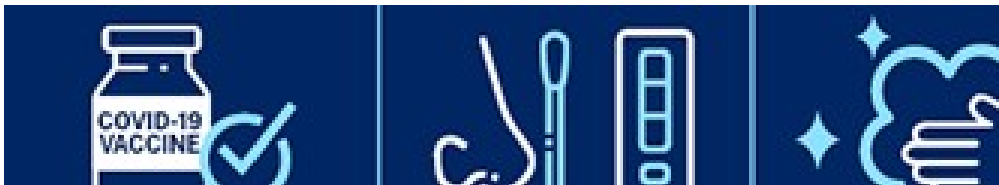
