Description of proposal

The application involves the construction and operation of the Woodlawn Advanced Energy Recovery Centre at the Woodlawn Eco Precinct near Tarago, comprising:

- an energy from waste facility with a capacity to generate up to 30 megawatts of electrical energy by thermally treating up to 380,000 tonnes per year of residual municipal solid waste and residual commercial and industrial waste;
- management of residual by-products (ash) generated by the facility, including:
 - incinerator bottom ash handling equipment, maturation area and disposal to landfill; and o on-site landfill cell for the disposal of air pollution control residues;
- ancillary infrastructure, including waste feedstock handling and storage area, administration buildings, education centre, landscaping and stormwater and drainage infrastructure;
- site access, internal access roads, parking and weighbridges; and
- utilities and services, including a new substation.

About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development.

The Department of Planning and Environment (Department) has received a State significant development (SSD) application for the abovementioned project.
