As per your instruction and with reference to your supplied documentation including Space Urban architectural drawings referenced 007348-01T, I have compiled and attached a *Capital Investment Value* estimate for the above noted project equating to \$3,296,470 excluding GST. As requested we have also included in the attachment the breakdown relating to Plant and Equipment costs totalling \$1,363,100 excluding GST.

The Capital Investment Value has been calculated to include for all costs necessary to establish and operate the project, including the design and construction of buildings, structures, associated infrastructure and fixed or mobile plant and equipment. All in accordance with the new definition of 'capital investment value' under the Environmental Planning and Assessment Regulation 2000.

The following are excluded as per the above noted definition:

- (a) amounts payable, or the cost of land dedicated or any other benefit provided, under a condition imposed under Division 6 or 6A of Part 4 of the Environmental Planning and Assessment Act or a planning agreement under that Division
- (b) costs relating to any part of the development or project that is the subject of a separate development consent or project approval
- (c) land costs (including any costs of marketing and selling land)
- (d) GST (as defined by A New Tax System (Goods and Services Tax) Act 1999 of the Commonwealth).

In terms of an estimate of the jobs that will be created by the development during the construction and operational phases of the proposed development, I can advise that during construction I believe approximately 6 jobs to be created and during the operational phase approximately 9 full time equivalent jobs will be enabled. These estimates are based on the project value and increased floor space areas applied to jobs data contained in industry resources.

In addition, I can confirm that the above and attached information provided in this report is accurate as of the date of this letter.
