Subject: Request to waive requirement to prepare a Biodiversity Development Assessment Report

I refer to your correspondence received on 21 December 2021 seeking to waive the requirement to prepare a biodiversity development assessment report (BDAR) to be submitted with the state significant development application for the proposed Ascent Warehouse and Distribution Centre, Alexandria (SSD-32489140).

Description of proposed development

The development seeks consent to construct and operate a multi-level warehouse and distribution centre with associated offices as detailed in the BDAR waiver application dated 21 December 2021 and prepared by Biosis Pty Ltd.

Under section 7.9(2) of the Biodiversity Conservation Act 2016 (BC Act):

“Any such application is to be accompanied by a biodiversity development assessment report unless the Planning Agency Head and the Environment Agency Head determine that the proposed development is not likely to have any significant impact on the biodiversity values”.

This letter is to confirm the Planning Secretary of the Department of Planning and Environment has determined the proposed development as described above is not likely to have any significant impact on biodiversity values and that a BDAR is therefore not required to accompany any application for development consent or infrastructure approval for the proposed development.

I, as delegate of the Planning Secretary have determined the proposed development is not likely to have any significant impacts on biodiversity values (see determination attached dated 9 March 2022). Evidence that the delegate of the Secretary within Environment, Energy and Science Division (Director Greater Sydney) has made the determination is also attached (dated 11 February 2022).

If there are any amendments to the proposed development, a fresh request for a BDAR waiver determination will be required or a BDAR may need to be prepared.

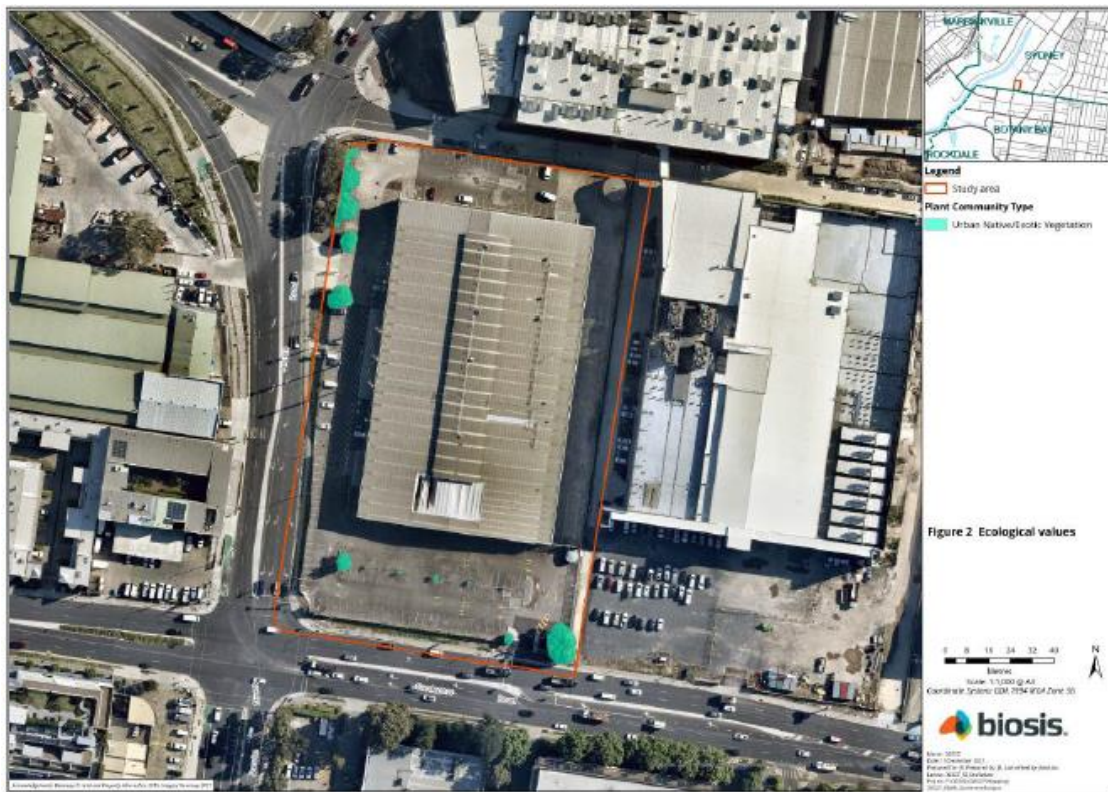
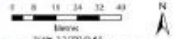


Figure 2 Ecological values
