## **RE: BUSHFIRE ASSESSMENT CONFIRMATION MOD 10, HUNTLEE**

MJD Environmental has been engaged by Huntlee Pty Ltd, to provide a review and bushfire confirmation in response to a query raised by NSW Department of Planning and Environment assessing officers in relation to a current 4.55 Modification (MOD 10) to Stage 1 of Major Project (MP10\_0137) for the Huntlee New Town Residential development, North Rothbury.

The query raised by the DPE relates to bushfire assessment over proposed lots 481, 482, 483, 484 and 1000 as highlighted via a red ellipse on the inset below. Specifically, assessing officers have requested confirmation these lots have been assessed as part of the MOD 10 bushfire threat assessment.

We draw the DPE assessing officers attention to the Bushfire Threat Assessment prepared by MJD Environmental (August 2018) to inform MOD 10. The assessment has been prepared in accordance with the deemed to satisfy provisions of PBP (2006) and specifically details the bushfire hazards, resulting APZ (PBP 2006) and BAL in accordance with AS 3959-2009. The assessment outcomes have been detailed throughout the report and clearly mapped on Figure 7 and Figure 9. Extracts of the assessment and mapping relating to the subject lots has been provided below.

The assessment and results demonstrate the proposed subdivision complies with the relevant APZ and BAL.

This report has been assessed and approved by the NSW RFS (ref: D18/659 30 October 2018). Note whilst the subject of this conformation relates to MOD 10, the report was prepared, referred to and assessed by the NSW RFS as MOD 9.



Notably a revised Bushfire Threat Assessment was prepared by MJD Environmental (2017) to accompany 75w Modification (MOD 8) to Stage 1 of Major Project (MP10\_0137) for the Huntlee New Town Residential development. The MJD Environmental (2017) BTA was assessed and approved by the NSW RFS. The current report reflects a revised subdivision pattern for the subject land and all other assessment elements and results remain concurrent.
