General Requirements	<ul> <li>The Environmental Impact Statement (EIS) must meet the minimum form and content requirements as prescribed by Part 8, Division 5 of the <i>Environmental Planning and Assessment Regulation 2021</i> (EP&amp;A Regulation) and must have regard to the <i>State Significant Development Guidelines</i>.</li> <li>In particular, the EIS must include: <ul> <li>stand-alone executive summary;</li> <li>a full description of the development, including: <ul> <li>details of construction, operation and decommissioning;</li> <li>a high quality site plan at an adequate scale showing all infrastructure and facilities (including any infrastructure that would be required for the development, but the subject of a separate approvals process);</li> <li>a high quality detailed constraints map identifying the key environmental and other land use constraints that have informed the final design of the development;</li> </ul> </li> <li>a strategic justification of the development focusing on site selection and the suitability of the proposed or approved major projects, rural/residential development, any Crown lands within or adjacent to the site and neighbouring industrial and infrastructure developments);</li> <li>an assessment of the likely impacts of the development on the environment, focusing on the specific issues identified below, including: <ul> <li>a description of the existing environment likely to be affected by the development using sufficient baseline data;</li> <li>an assessment of the likely impacts of all stages of the development, (which is commensurate with the level of impact), including any cumulative impacts of the site and existing or proposed development, with the level of impact), including any cumulative impacts of the site and existing or proposed development.</li> </ul> </li> </ul></li></ul>

The calculation of the estimated CIV is to be accurate at the date of application and include details of all components and assumptions from which it is derived; and Provide an estimate of the retained and new jobs that would be created du
	<ul> <li>The development application must be accompanied by:</li> <li>the consent of the owner/s of the land (as required in clause 23(1) of the EP&amp;A Regulation);</li> <li>a declaration from a Registered Environmental Assessment Practitioner that the EIS includes the information specified in the Department's <i>Registered Environmental Assessment Practitioner Guidelines</i>.</li> </ul>
Key issues	<ul> <li>The EIS must address the following specific matters:</li> <li>Biodiversity – including: <ul> <li>an assessment of the biodiversity values and the likely biodiversity impacts of the project in accordance with Section 7.9 of the <i>Biodiversity Conservation Act 2016</i> (NSW), the Biodiversity Assessment Method (BAM) and documented in a Biodiversity Development Assessment Report (BDAR), unless BCS and DPIE determine the proposed development is not likely to have any significant impacts on biodiversity values;</li> </ul> </li> </ul>

•	<ul> <li>the BDAR must document the application of the avoid, minimise and offset framework including assessing all direct, indirect and prescribed impacts in accordance with the BAM; and</li> <li>if an offset is required, details of the measures proposed to address the offset obligations.</li> <li>Heritage – including:</li> <li>an assessment of the impact to Aboriginal cultural heritage items (cultural and archaeological) in accordance with the <i>Guide to Investigating, Assessing and Reporting on Aboriginal Cultural Heritage in NSW</i> (OEH, 2011) and the <i>Code of Practice for the Archaeological Investigation of Aboriginal Objects in NSW</i> (DECCW, 2010), including results of archaeological test excavations (if required);</li> </ul>
	<ul> <li>evidence of consultation with Aboriginal communities in determining and assessing impacts, developing options and selecting options and mitigation measures (including the final proposed measures), having regard to the <i>Aboriginal Cultural Heritage Consultation Requirements for Proponents</i> (DECCW, 2010); and</li> <li>assess the impact to historic heritage having regard to the <i>NSW Heritage Manual</i>.</li> </ul>

	<ul> <li>existing site constraints;</li> <li>an assessment of the potential impacts of the development on existing land uses on the site and adjacent land, including: <ul> <li>flood prone land, acid sulphate soils, Crown lands, mining, quarries, mineral or petroleum rights;</li> <li>a soil survey to determine the soil characteristics and consider the potential for erosion to occur; and</li> </ul> </li> </ul>
	<ul> <li>a cumulative impact assessment of nearby developments;</li> <li>an assessment of the compatibility of the development with existing land uses, during construction, operation and after decommissioning, including:</li> </ul>
	<ul> <li>consideration of the zoning provisions applying to the land, including subdivision (if required);</li> <li>completion of a Land Use Conflict Risk Assessment in accordance with the Department of <i>Industry's Land Use Conflict</i></li> </ul>
•	<ul> <li><i>Risk Assessment Guide</i>; and</li> <li>assessment of the impact on agricultural resources and agricultural production on the site and region.</li> <li>Visual – including a detailed assessment of the likely visual impacts</li> </ul>
	(including night lighting) of all components of the project (including transmission lines and any other ancillary infrastructure) on surrounding residences, scenic or significant vistas and road corridors in the public domain.
•	<b>Noise</b> – including an assessment of the construction noise impacts of the development in accordance with the <i>Interim Construction Noise Guideline</i> (ICNG), operational noise impacts in accordance with the <i>NSW Noise Policy for Industry</i> (2017), cumulative noise impacts (considering other developments in the area), and a draft noise management plan if the

assessment shows construction noise is likely to exceed applicable criteria;

<ul> <li>an assessment of the peak and average traffic generation, including over-dimensional vehicles, construction worker transportation and transport of materials by rail;</li> <li>an assessment of the likely transport impacts to the site access route, site access point(s), any Crown land, particularly in relation to the capacity and condition of the roads, road safety and intersection performance;</li> </ul>
<ul> <li>a cumulative impact assessment of traffic from nearby developments; and</li> </ul>
<ul> <li>provide details of measures to mitigate and / or manage potential impacts including a schedule of all required road upgrades (including resulting from heavy vehicle and over mass / over dimensional traffic haulage routes), road maintenance contributions, and any other traffic control measures, developed in consultation with the relevant road authority;</li> </ul>
Water – including:
<ul> <li>an assessment of the likely impacts of the development (including flooding) on surface water and groundwater resources and measures proposed to monitor, reduce and mitigate these impacts;</li> <li>details of water requirements and supply arrangements for construction and operation; and</li> </ul>
<ul> <li>a description of the erosion and sediment control measures that would be implemented to mitigate any impacts in accordance with <i>Managing</i> <i>Urban Stormwater: Soils &amp; Construction</i> (Landcom 2004);</li> </ul>
<ul> <li>Hazards – including:         <ul> <li>a preliminary risk screening completed in accordance with <i>State Environmental Planning Policy No. 33 – Hazardous and Offensive Development and Applying SEPP 33</i> (DoP, 2011);</li> <li>a Preliminary Hazard Analysis (PHA) must be prepared in accordance with the <i>Hazardous Industry Planning Advisory Paper No. 6, 'Hazard Analysis' and Multi-Level Risk Assessment</i> (DoP, 2011). The PHA must consider all recent standards and codes and verify separation distances to on-site and off-site receptors to prevent fire propagation and compliance with <i>Hazardous Industry Planning</i> (DoP, 2011); and</li> <li>an assessment of potential hazards and risks including but not limited to bushfires, land contamination, spontaneous ignition, electromagnetic fields or the proposed grid connection infrastructure against the <i>International Commission on Non-Ionizing Radiation Protection (ICNIRP) Guidelines for limiting exposure to Time-varying Electric, Magnetic and Electromagnetic Fields;</i></li> </ul> </li> <li>Social Impact – including an assessment of the social impacts in accordance with <i>Social Impact Assessment Guideline</i> (DPIE, 2021);</li> </ul>
<ul> <li>Economic – including an assessment of the economic impacts or benefits of the project for the region and the State as a whole; and</li> <li>Waste – identify, quantify and classify the likely waste stream to be generated throughout all stages of the project, and describe the measures</li> </ul>

	to be implemented to reduce waste generation, manage, reuse, recycle and safely dispose of this waste.
Plans and Documents	The EIS must include all relevant plans, architectural drawings, diagrams and relevant documentation required under Part 3 of the Regulation. Provide these as part of the EIS rather than as separate documents.
	In addition, the EIS must include high quality files of maps and figures of the subject site and proposal.
Legislation, Policies & Guidelines	The assessment of the key issues listed above must take into account relevant guidelines, policies, and plans as identified.

	<ul> <li>The EIS must:</li> <li>detail how engagement undertaken was consistent with the Undertaking Engagement Guide: Guidance for State Significant Projects (DPIE, Nov 2021); and</li> </ul>
	<ul> <li>describe the consultation process and the issues raised and identify where the design of the development has been amended in response to these issues. Where amendments have not been made to address an issue, an explanation should be provided.</li> </ul>
