Hi Alana

Following on From Greg's email....likewise I am unable to locate the Centennial Northern Coal Services Reject Emplacement Area Strategy.

Does this address the outcomes from the Tailings Storage Facility Targeted Assessment Program (TAP) undertaken in 29 Jan 2020, and the Materials and Soils (TAP) undertaken 27 August 2020.

The MOP is a bit light on in terms of Capping design and strategy, lacks details with Strategies to maximise consolidation and strength profile of the emplaced tailings material to allow for effective and efficient capping of the dam, and what long-term settlement risks for the final landform have been assessed and what controls are to be considered and implemented. I note in the MOP it mentions the SREA capping to final landform, including coarse rejects - capped with a final cover design with approximately 1.5 metres of coarse rejects and then further covered with 0.5 metres of inert capping material and topsoil prior to being revegetated.

The MOP also advises that "a Detailed Tailings Capping Design will be developed and submitted for approval to the Resources Regulator (or contemporary equivalent) prior to commencing rehabilitation with a High Risk Activity approval issued under the Work Health and Safety (Mines) Regulation 2014".

To let you know some Title Holders specifically address any 240 Notice(s) and TAP findings within Section 2 of MOP as in a specific table which identifies each matter and how they've been addressed ie in what section of the MOP/Appendices etc...Or if it does not, then it will advise why and where it may be up too.
