













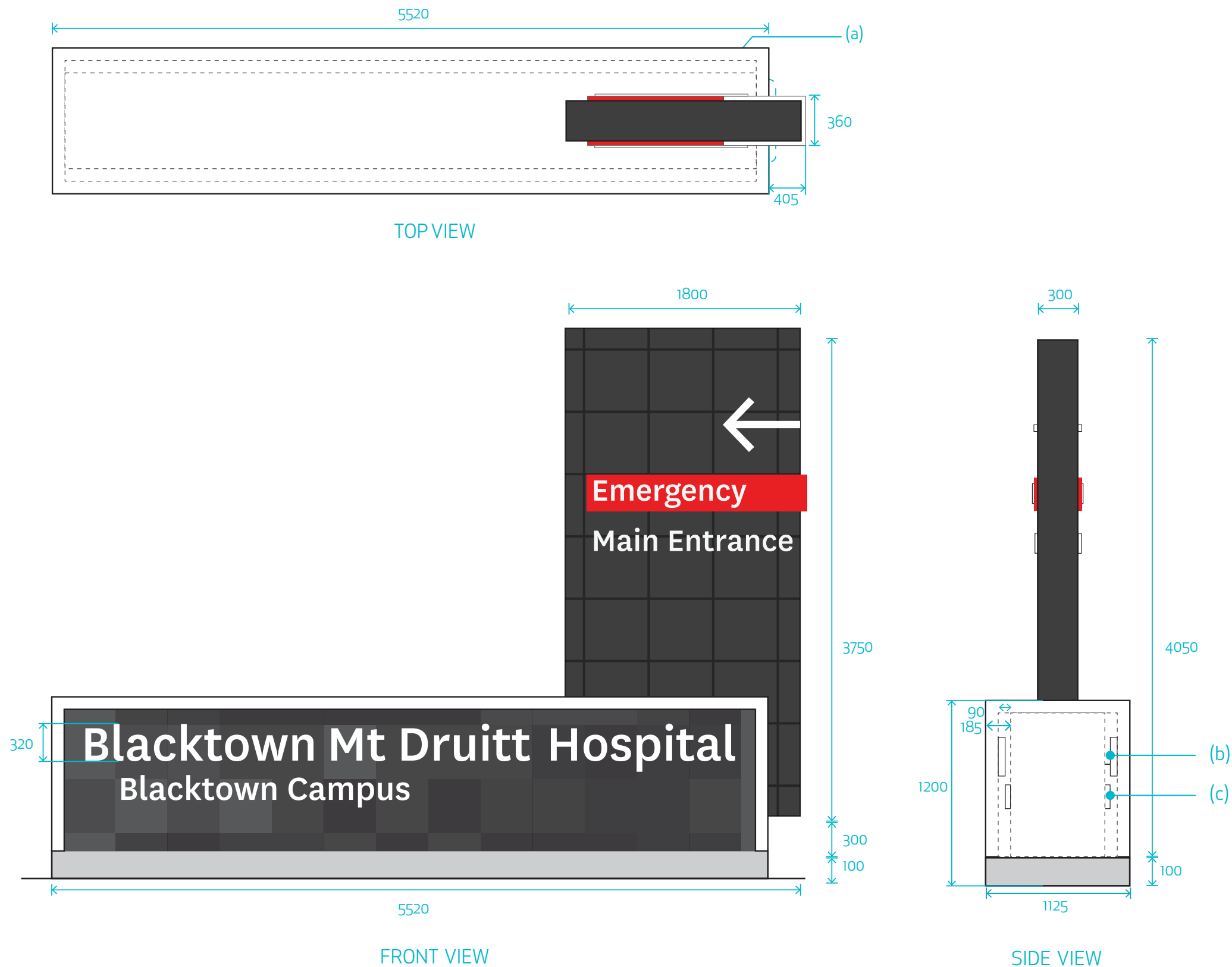

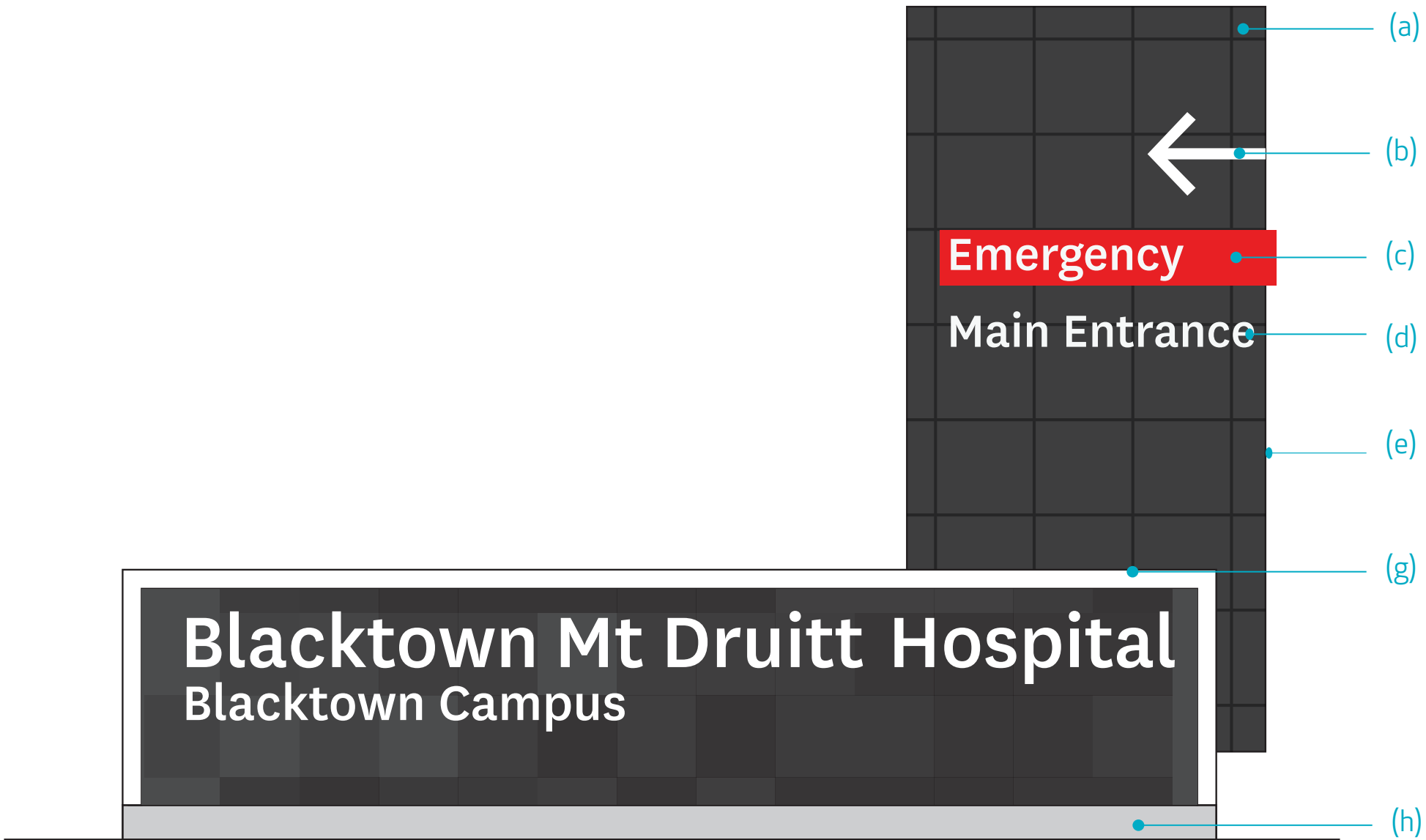


## Campus Entry Statement

- a) Allow for an expansion gap between horizontal and vertical element
- b) 40mm text with 30mm spacer
- c) 30 mm text

### Campus Entry Statement

- a) Internal, galvanised, steel frame to engineers specifications
- b) White arrow is 40 mm thick, and wraps around vertical box
- c) Red Emergency box is 40 mm thick, and wraps around. Red vinyl application on white acrylic
- d) Main Entrance text is intracut, with 20mm thick acrylic letters
- e) Maintenance access via side panels
- f) All internal illumination via LED. Power provided by services contractor
- g) ACM, charcoal grey, cladding, with minimal visible joints. Charcoal is painted, as are the black grid lines
- h) 100mm concrete footing around base of signage.
- i) All sign elements are finished with an anti graffiti coating
- j) Footing designed by manufacturer's engineer
- k) Arrow and Emergency box wrap around vertical box
