BUILDING CERTIFICATION

Future Music Festival utilizes the existing facilities at Randwick Racecourse as well as building temporary staging, marquees, and toilets. All our suppliers engaged in supplying temporary structures at our events carry all the appropriate insurances and design certificates for their structures. For the larger staging and marquee structures an engineer signs off after completion of the build.

FIRE SAFETY/STRUCTURE CAPACITIES

All temporary structures are fitted with fire extinguishers and Exit Signage where appropriate and in accordance to their occupancy permits. Once the site is setup we invite the Local NSW Fire Department down for an inspection of the site. Enclosed structures like Marquee's & Grandstands will have capacity limits and security will monitor these areas to avoid overcrowding.

WIND RATINGS

All temporary structures on the site will have wind ratings assigned to them. This information will be given to the EOC on the day of the event incase we experience adverse weather conditions during the event.

TOILETS

Apart from the existing toilets at the racecourse we compliment them with portable single toilets and larger 16 panner toilet blocks. We work on a ratio of 1 toilet per 85 patrons.
