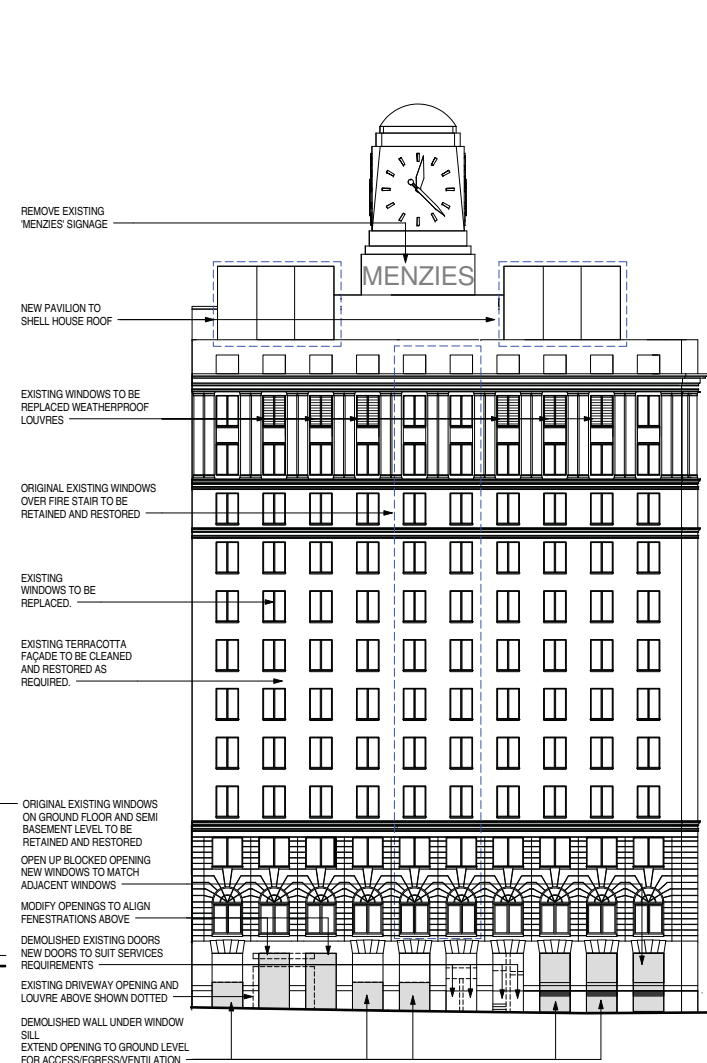
1 Carrington Street Elevation

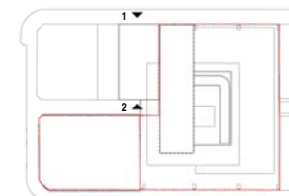
2 Margaret Street Elevation

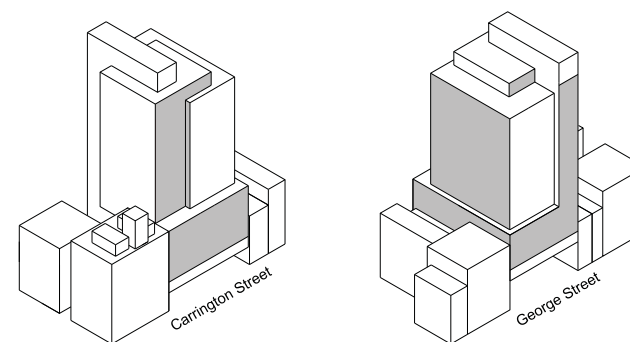
01 Typical Office Elevation

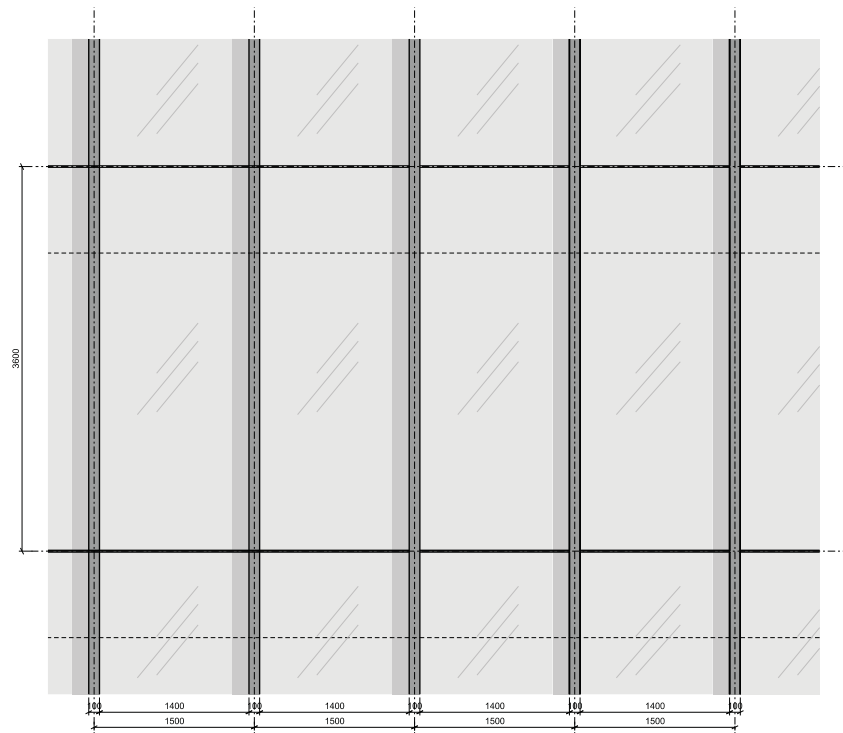

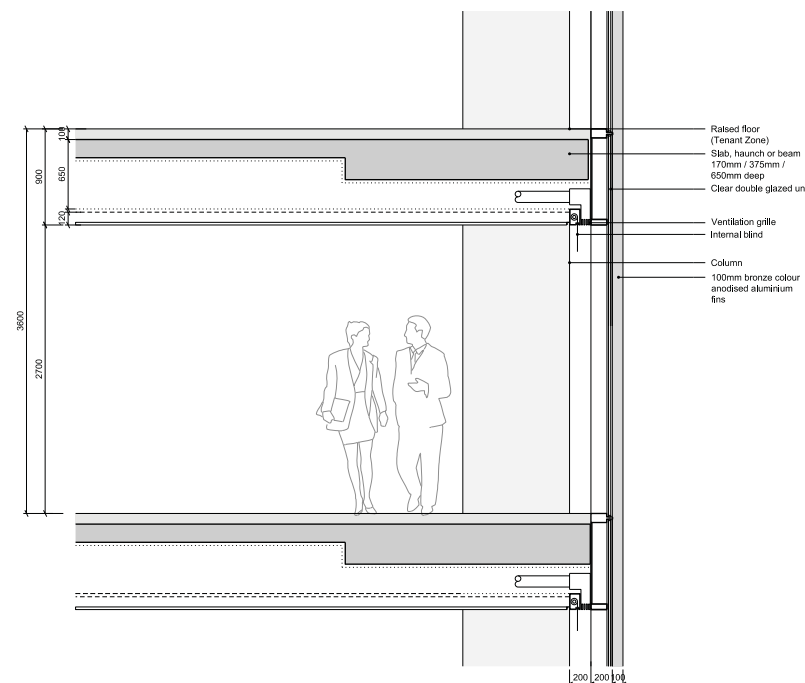

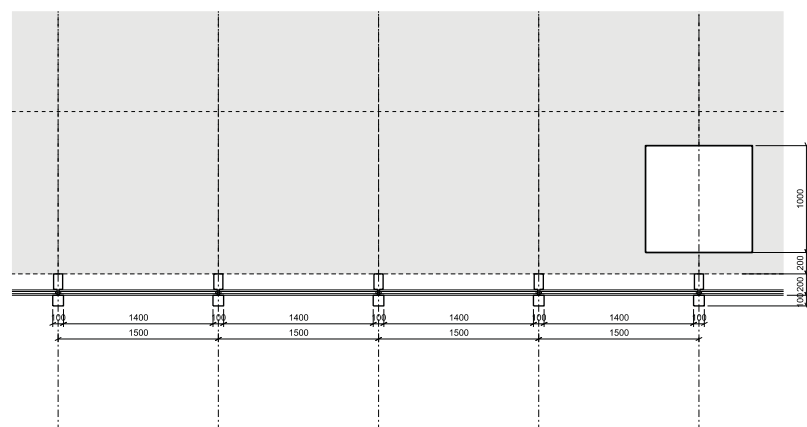
01 Typical Office Elevation

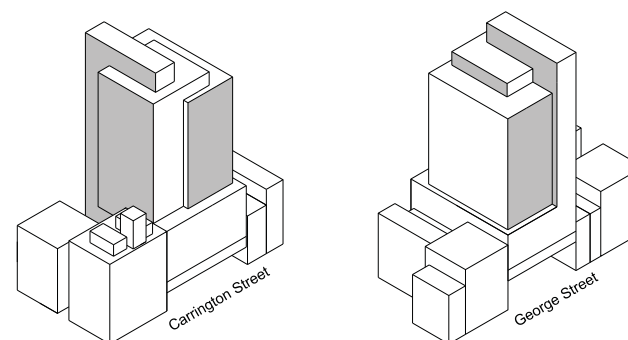
03 Typical office section

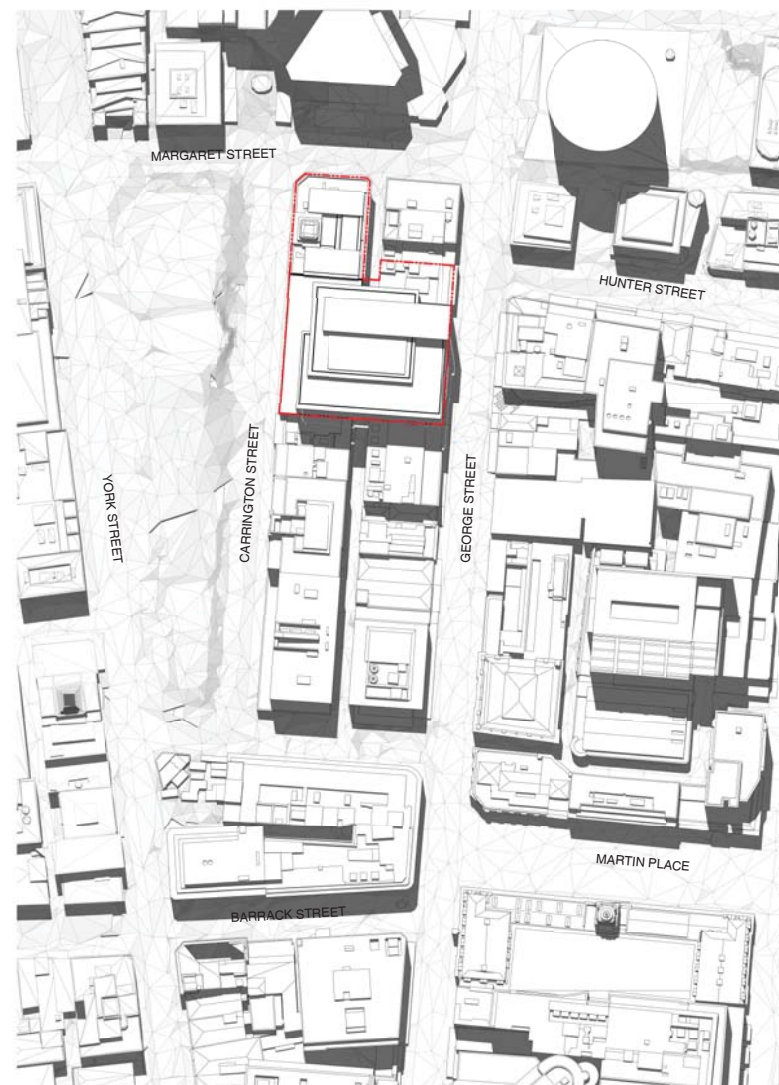
