General Requirements	<ul> <li>The Environmental Impact Statement (EIS) for the development must comply with the requirements in part 8, Division 5 of the <i>Environmental Planning and Assessment Regulation 2021</i> (the Regulation) and must have regard to the State Significant Development Guidelines and the Large-Scale Solar Energy Guideline (2022) (Solar Guideline).</li> <li>In particular, the EIS must include: <ul> <li>a stand-alone executive summary;</li> <li>a full description of the development, including: <ul> <li>details of construction, operation and decommissioning, including any staging of the development;</li> <li>a high quality site plan at an adequate scale showing all infrastructure and facilities (including any infrastructure that would be required for the development, but the subject of a separate approvals process);</li> <li>a high quality detailed constraints map identifying the key environmental and other land use constraints that have informed the final design of the development;</li> </ul> </li> <li>a strategic justification of the development focusing on site selection and the suitability of the proposed site with respect to potential land use conflicts with existing and future surrounding land uses (including existing land use, other proposed or approved energy facilities, major projects, rural/residential development, Crown lands within and adjacent to the project site, and subdivision potential) having regard to the Solar Guideline;</li> </ul></li></ul>

<ul> <li>a risk assessment of the potential impacts of the development, identifying the key issues for further assessment;</li> </ul>
<ul> <li>an assessment of the likely impacts of the development on the environment, and any other significant issues identified in this risk assessment, focusing on the specific issues identified below, including: <ul> <li>a description of the existing environment likely to be affected by the development using sufficient baseline data;</li> <li>an assessment of the likely impacts of all stages of the development, (which is commensurate with the level of impact), including any cumulative impacts of the site and existing, approved or proposed developments in the region and impacts on the site and any road upgrades, taking into consideration any relevant legislation, environmental planning instruments, guidelines, policies, plans and industry codes of practice including the Solar Guideline and the <i>Cumulative Impact Assessment Guideline</i> (DPIE, 2021);</li> <li>a description of the measures that would be implemented to avoid, mitigate and/or offset the impacts of the development (including draft management plans for specific issues as identified below); and</li> </ul> </li> </ul>

The calculation of the estimated CIV is to be accurate at the date of application and include details of all components and assumptions from which it is derived.</li> <li>Provide an estimate of the retained and new jobs that would be created during the construction and operational phases of the development, including details of the methodology to determine the figures provided.</li> </ul>
	<ul> <li>The development application must be accompanied by:</li> <li>the consent of the owner/s of the land (as required in Section 23(1) of the EP&amp;A Regulation); and</li> <li>a declaration from a Registered Environmental Assessment Practitioner that the EIS includes the information specified in the Department's <i>Registered Environmental Assessment Practitioner Guidelines</i>.</li> </ul>

	<ul> <li>Biodiversity – including:</li> <li>an assessment of the biodiversity values and the likely biodiversity impacts of the project in accordance with Section 7.9 of the <i>Biodiversity Conservation Act 2016</i> (NSW) (BC Act), the <i>Biodiversity Assessment Method</i> (BAM) 2020 and documented in a Biodiversity Development Assessment Report (BDAR),</li> <li>The BDAR must:     <ul> <li>be prepared using the approved BDAR template;</li> <li>document the application of the avoid, minimise and offset framework including assessing all direct, indirect and prescribed impacts in accordance with the BAM</li> <li>assess the impacts associated with all ancillary infrastructure, including the transport route road upgrades;</li> <li>include an assessment for SAII in accordance with Section 9.1 of the BAM.</li> <li>an assessment of the likely impacts on listed aquatic threatened species, populations or ecological communities, scheduled under the <i>Fisheries Management Act 1994</i>, and a description of the measures to minimise and rehabilitate impacts;</li> </ul> </li> <li>a cumulative impact assessment of biodiversity values in the region from nearby developments; and</li> <li>if an offset is required, details of the measures proposed to address the offset obligation.</li> </ul>

- a soil survey to determine the soil characteristics and consider the potential for salinity, acid sulfate soils and erosion to occur;

- an assessment of the compatibility of the development with existing land uses, during construction, operation and after decommissioning, including:
  - consideration of the zoning provisions applying to the land, including subdivision (if required);
  - an assessment of agricultural impacts in accordance with the Solar Guideline.

 a landscape and visual impact assessment, prepared in accordance with the Solar Guideline and the Technical Supplement – Landscape and Visual Impact Assessment;

 a detailed assessment of the likely visual impacts of all components of the project on surrounding residneces (including approved developments, lodged development applications and dwelling entitlements), and key locations, scenic of significant vistas and road corridors in the public domain; and

 details of measures to mitigate and/or manage potential impacts (including a draft landscaping plan for on-site perimeter planting, with evidence it has been developed in consultation with affected landowners).

Plans and Documents	The EIS must include all relevant plans, diagrams and relevant documentation required under Part 3 of the EP&A Regulation. Provide these as part of the EIS rather than as separate documents. In addition, the EIS must include high quality files of maps and figures of the subject site and proposal.
	<ul> <li>provide details of any proposed voluntary benefit sharing programs in accordance with the Solar Guideline.</li> <li>Waste – including: <ul> <li>identify, quantify and classify the likely waste stream to be generated during construction and operation, and describe the measures to be implemented to manage, reuse, recycle and safely dispose of this waste; and</li> <li>provide a waste management plan prepared in accordance with the Solar Guideline.</li> </ul> </li> </ul>
