Description of proposal

The Maules Creek Coal Mine is an existing open cut coal mine located in the Narrabri local government area that is approved to operate until 2034.

Maules Creek Coal Pty Ltd has lodged a new development application to extend the mine life to 2044; to expand the mining area to extract an additional 117 million tonnes of run-of-mine (ROM) coal; and to increase the ROM coal processing rate from 13 million tonnes per annum to 14 million tonnes per annum.

About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development.

The Department of Planning, Housing and Infrastructure (Department) has received a State significant development application for the abovementioned project. The application, environmental impact statement, and accompanying documents are on exhibition from Tuesday 24 June 2025 until Monday 4 August 2025. At the time of publishing this advertisement, the Minister for Planning and Public Spaces has not directed that a public hearing should be held.

Controlled Action under Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act)

Development in NSW can be subject to Commonwealth legislation, depending on the circumstances.

The Commonwealth Minister for the Environment and Water has decided that the proposed development – known as the Maules Creek Coal Mine Continuation Project (2024/09936) for Commonwealth purposes – is a "controlled action" under the EPBC Act.

The EPBC Act Part 3, Division 1 controlled provisions are:

- Sections 18 and 18A (listed threatened species and communities); and
- Sections 24D and 24E (protection of water resources from coal seam gas development and large coal mining development).

The proposed development (2024/09936) will be assessed under Part 4 of the *Environmental Planning and Assessment Act 1979.* The assessment will be in accordance with the Bilateral Agreement between NSW and the Commonwealth, made under the EPBC Act. The assessment will be done in the manner specified in Schedule 1 of the Bilateral Agreement. This means the project will be assessed against the requirements of both acts.
