Overhead Gantry

B35. Prior to the issue of the relevant Construction Certificate, RMS shall be consulted on the detailed design and installation of the overhead gantry. The plans must be submitted to and approved by the Barangaroo Delivery Authority as the relevant roads authority.

3. Condition E8 is imposed by the insertion of the **bold and underlined** words/numbers as follows:

Moreton Bay Fig Tree

E8 No later than one month after the commencement of the works, a replacement Moreton Bay Fig Tree (of equivalent size and maturity) must be planted in the same location as the

Moreton Bay Fig Tree known as Tree 45. Written notification to the Secretary within seven days of planting must be provided to demonstrate compliance with this condition.
