Lucas Heights Landfill - Temporary Extension of Operating Hours

I refer to your letter of 23 September 2022 to the NSW Environment Protection Authority (EPA) seeking an extension to the temporary change to the hours of operation at the Lucas Heights Landfill (Environment Protection Licence No. 5065).

The EPA notes your advice that ongoing wet weather continues to create challenges for operation of the landfill. The EPA also understands that are 'knock-on' impacts, with Cleanaway's Transfer Stations sometimes unable to receive waste from commercial operators.

We note your advice that Cleanaway continues to work to improve the conditions of the tip face and access roads at the landfill. Given the need to maintain availability of putrescible waste disposal options within the network, the EPA agrees with Cleanaway's request to extend the operating hours at Lucas Heights to allow the disposal of household and commercial putrescible waste.

The EPA agrees to Cleanaway's request that the Lucas Heights Landfill can operate in accordance with the hours of operation set out below.

Day Hours of Operation

Monday to Friday 3 am to 5 pm Saturday 5 am to 4 pm Sunday 6 am to 4 pm

The EPA understands that you have also sought Department of Planning and Environment agreement with this further proposed extension to the hours of operation.

We note Cleanaway's advice that these hours would be in place for 3 months whilst it applies for permanent changes via the Department of Planning & Environment, and then the EPA. The above temporary arrangements will therefore cease at 4pm on Saturday 31 December 2022.
