**One Sydney Harbour, Building R4B Barangaroo South – Section 4.55(2) Modification  
Application for State Significant Development SSD 6965 (Fire Safety Engineering)**

This letter has been prepared by Warringtonfire for Lendlease to support an application that is to be made pursuant to Section 4.55 of the Environmental Planning and Assessment Act 1979 to modify the approval issued in respect of SSD 6965 for One Sydney Harbour, Building R4B at Barangaroo South.

This modification application seeks consent for amendments to the total number of apartments, the apartment mix, layouts and car parking allocation. Design modifications are also proposed to the fenestration of the façade and to the podium rooftop landscaping.

Broadly, the following amendments are sought as part of this modification application:

- increase in the number of apartments from 283 to 290;
- revised dwelling mix and internal layout changes;
- changes to the landscaped podium layout; and
- changes to the number of car spaces from 320 to 324.

Defire (now trading as Warringtonfire) previously prepared a preliminary fire engineering review dated 9 August 2016 which was used to support the original project application. Our review concluded that it would be possible to develop performance solutions for identified departures from the deemed-to-satisfy provisions of the National Construction Code (NCC) without major changes to the proposed design.

The extent of changes proposed in the Section 4.55 application are considered not to impact on the previous fire engineering review and it is Warringtonfire's opinion that the proposed modification to SSD 6965 does not require any additional supporting information, analysis or commentary.
