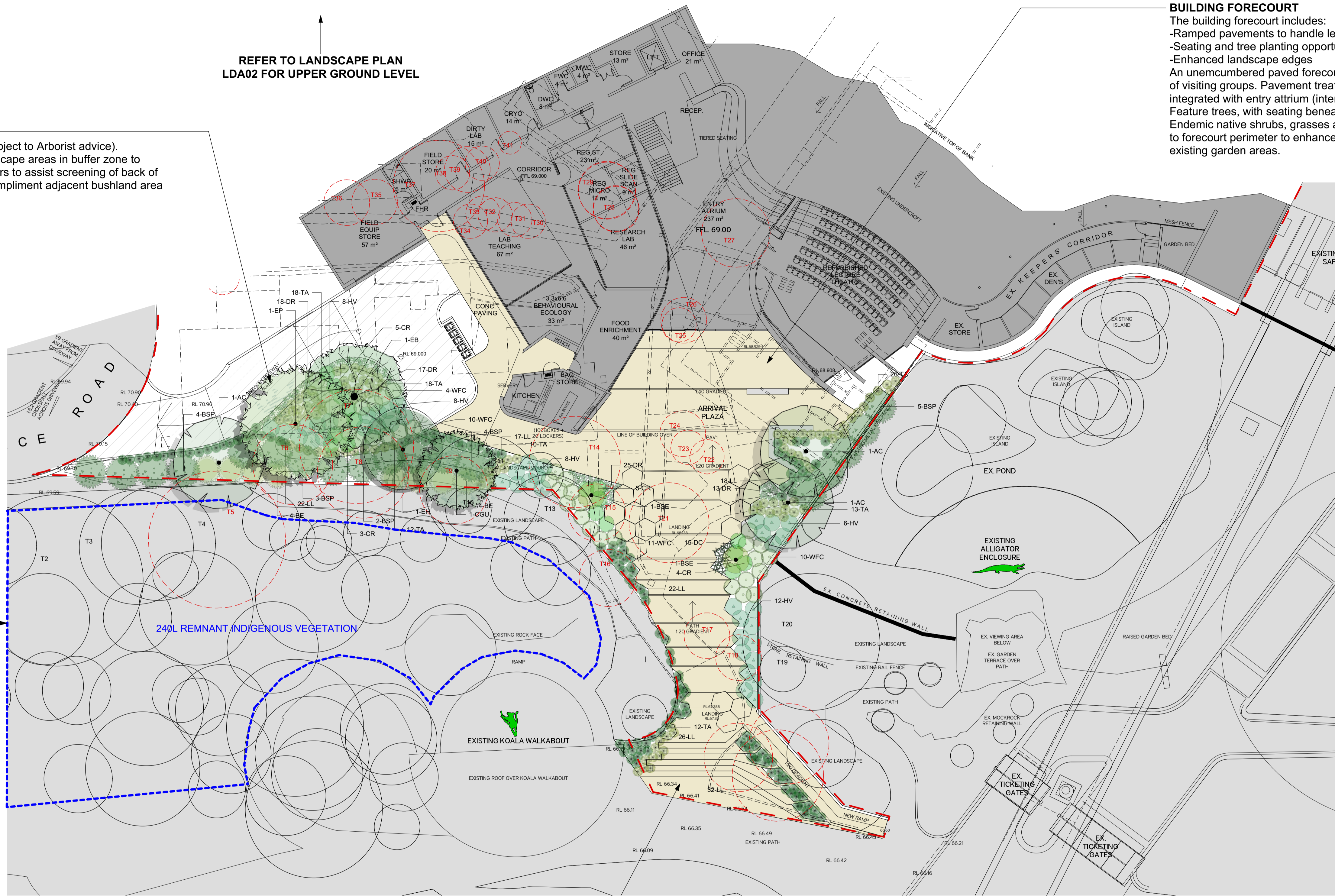


REFER TO LANDSCAPE PLAN
LDA02 FOR UPPER GROUND LEVEL

BUFFER PLANTING
Existing trees to be retained where possible (subject to Arborist advice). Mounded landscape area in regenerated Landscape areas in buffer zone to elevate native shrubs, grasses and ground covers to assist screening of back of house areas. Infill planting or native trees to compliment adjacent bushland area

BUILDING FORECOURT
The building forecourt includes:
-Ramped pavements to handle level change
-Seating and tree planting opportunities
-Enhanced landscape edges
An unencumbered paved forecourt to handle movement of visiting groups. Pavement treatments to be integrated with entry atrium (internal finish). Feature trees, with seating beneath. Endemic native shrubs, grasses and groundcovers to forecourt perimeter to enhance interface with existing garden areas.

ENTRY:
The sites main entry features:
-Broad Steps
-Integrated landscape and informal seating
-Access ramp
Removal of existing garden areas provides improved physical and visual connection from main circulation path to the new building. Wide steps to handle group movements, informal seating opportunities and planted zones
