SSDA Modification – Design Development

The below register outlines key design development and areas of change aligned with the Architectural SSDA Modification drawing issue.

Location	Design Changes
Site plan	Site plan reflects general design development made to the roof, including skylight removal, alignment with mechanical layouts below, roof access points added and alignment with hydraulic drainage strategy.
Gross Floor Area	Marginally reduced Gross Floor Area (GFA) reflecting general design development, including removal of internal voids, stair width and plant rooms.
Lower Ground	General architectural design development, including reduced stair width to lower ground level, minor amendment to amenities configurations, alignment of Fire stair 1 wall with lift core, responding to piling wall structural coordination.
Ground	Ground Updated Landscape design (Refer Landscape Architect plans and report). General architectural design development, including reduced stair width to lower ground level, minor amendment to amenities configurations, alignment of Fire stair 1 wall with lift core, cleaner's cupboards added, entries amended, additional door to substation, note added for secondary fire booster in alignment with FEBQ.
Level 1	General architectural design development, including door configuration amendments and cleaner's cupboard addition to central core.
Level 2	General architectural design development, including door configuration amendments, additional AV plant room and cleaner's cupboard addition to central core.
Level 3	General architectural design development, including door configuration amendments, additional AV plant room and cleaner's cupboard addition to central core.
Level 4	General architectural design development, including door configuration amendments, additional AV plant room and cleaner's cupboard addition to central core.
Level 5	General architectural design development, including door configuration amendments, additional AV plant room and cleaner's cupboard addition to central core.
Level 6	General architectural design development, including door configuration amendments, additional AV plant room and cleaner's cupboard addition to central core.
Level 7	General architectural design development, including door configuration amendments, additional AV plant room, removal of internal void, door relocation to external terrace and cleaner's cupboard addition to central core.
Level 8	General architectural design development, including door configuration amendments, green roof planting to Southern terrace (refer Landscape drawings), removal of internal void and cleaner's cupboard addition to central core.

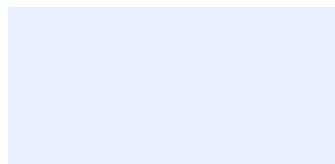

Roof	General design development made to the roof, including skylight removal, alignment of roof openings with mechanical layouts below, roof access points added and alignment with hydraulic drainage strategy.
Elevations	High level window added to Ground floor classroom (under awning). Door locations amended to respond to amended Landscape Design (refer Landscape Design documentation). Additional safety tensile mesh FAC06 added to Level 7 external terrace in response to Safety In Design considerations.
Materials & Finishes Schedule	Additional safety tensile mesh FAC06 added to Level 7 external terrace in response to Safety In Design considerations.
