The Modifications seek to increase the cumulative run-of-mine (ROM) coal haulage limit from the currently consented 3.5 million tonnes per annum (Mtpa) to a total of 4.1 Mtpa for calendar years 2026 to 2030, without constructing the Kamilaroi Highway overpass. The 0.6 Mtpa increase to hauled ROM coal would apply to the southern section of the Approved ROM Coal Transport Route.
