Just giving you a heads up, we will be requesting for Built to instruct Webber to put together a pack to satisfy Condition B7a for CC3.

## See below DA Condition:

Prior to issue of Construction Certificate add new B7A as follows:

Prior to issue of Construction Certificate 3 – Foundations/ in ground structure (CC3), amended plans are required showing detailed design of the opening between function rooms 7 and 8. The plans are to show the retention of substantial wall nibs and head, and a line in the flooring to interpret the original wall configuration, prepared in consultation with the project heritage consultant, Heritage Council and Council, and submitted to the satisfaction of the Planning Secretary.

We are expecting a set of drawings from BAR on 6th August which describe the design intent in this area which captures the Nib retention.

EPM will be sending you this information to enable Webber to prepare a draft pack for Urbis Review by late August 2019.

Urbis has advised the following is required in this pack:

- A proposed detailed drawing documenting the proposal would be sufficient - plan, reflected ceiling plan and elevation probably on a single A3 page. It will need to be reviewed by us. Perhaps then sent by Ethos to the City of Sydney first and then the Heritage Division and then the Department.
