This Mod seeks to amend the table in Schedule 2, Condition A1 to reference an updated Proposed Plan of Subdivision along with Appendix A of the Development Consent. Further, amend Schedule 3, Condition A14 to reflect updated Proposed Plan of Subdivision.

This Mod further seeks to amend Schedule 2, Condition A11, Table 2 to allow 2,848m<sup>2</sup> of Office Gross Floor Area by increasing the GFA Maximum under the Concept Development for Total Office GFA to 3,000m<sup>2</sup> and reducing the Total Warehouse.

How is the modification substantially the same as the original development?

The proposed modifications do not alter the key components of the approved development description.
