Frequently Asked Questions

What is proposed?

- The applicant is seeking approval for the use of Tenancy 5 of the Overseas Passenger Terminal (OPT) for an indoor and outdoor restaurant and bar, incorporating a micro-brewery.
- · The works include:
 - A change to the northern section of the OPT building including:
 - new windows and door openings
 - o new ground floor terrace
 - o additional outdoor seating areas
 - o new level two balcony on the western elevation
 - o new outdoor decks on level two on the east and north elevations
 - o awnings/sun shading structures
 - o landscaping
 - o new micro-brewery pod.
 - Outdoor service/walk up bar beneath the micro-brewery pod
 - Installation of a gantry (access walkway) connecting the north facing balcony with the microbrewery pod
 - Removal of six palm trees
 - Business identification signage zones
 - General hours of operation 6am to 12 midnight Sunday to Thursday inclusive; 6am Friday to 1am Saturday; 6am Saturday to 1am Sunday; and 6am New Year's Eve to 2am New Year's Day (inclusive).

The application also proposes a change to the Sydney Cove Redevelopment Authority Scheme. This would enable development consent to be granted to the proposed micro-brewery pod, gantry/access walkway and a portion of the north facing balcony.

Why has this application been proposed?

• The applicant is Jimmy's on the mall, who are proposing a restaurant and bar and micro-brewery within the vacant tenancy 5 of the OPT.

Who assesses the proposal?

• The Department of Planning and Environment (the Department) assesses the proposal as it's within The Rocks Site, and it seeks to vary the *Sydney Cover Redevelopment Authority* Scheme. This constitutes a State Significant Development.

What consultation has been undertaken to date?

• Before the application was lodged, the Department required Jimmy's on the mall, to undertake consultation with local and State authorities, community groups and affected landowners.
