For the following:	Construction and operation of the Dubbo Base Hospital Redevelopment Stage 4, including: • demolition works (George Hatch building, 'S' Block, childcare centre, doctor's accommodation, part of ambulatory care unit) and removal of 75 trees; • earthworks; • construction of a four-storey building comprising 11,100 sqm of gross floor area, including 26 new in-patient beds, emergency department, medical imaging, renal dialysis, ambulatory care services, coronary care unit, intensive care unit, cardiovascular suite and plant room; • at-grade car park areas providing a total of 131 car spaces, new Ambulance access off Myall Street, new drop off/pick-up zone and reconfiguration of the Cobbora Road roundabout; and • landscaping
