Construction of a Secondary Innovation Precinct within the Pymble Ladies' College campus including:

- demolition, site preparation and excavation
- tree removal
- construction of a 6-storey school building with rooftop plant
- minor road adjustments
- soft and hard landscaping.

No change to student or staff numbers is proposed.
