SCHEDULE 2 ADMINISTRATIVE CONDITIONS

OBLIGATION TO MINIMISE HARM TO THE ENVIRONMENT

In addition to meeting the specific environmental performance criteria established under this consent, the
Applicant must implement all reasonable and feasible measures to prevent and/or minimise any material
harm to the environment that may result from the construction, operation or decommissioning of the
development.

TERMS OF CONSENT

- 2. The Applicant must carry out the development:
 - (a) generally in accordance with the EIS;
 - (b) in accordance with the conditions of this consent.

Note: The general layout of the development is shown in Appendix 1.

- If there is any inconsistency between the above documents, the most recent document must prevail to the
 extent of the inconsistency. However, the conditions of this consent must prevail to the extent of any
 inconsistency.
- 4. The Applicant must comply with any reasonable requirement/s of the Secretary arising from the Department's assessment of:
 - (a) any strategies, plans or correspondence that are submitted in accordance with this consent;
 - (b) any reports, reviews or audits commissioned by the Department regarding compliance with this consent; and
 - (c) the implementation of any actions or measures contained in these documents.

FINAL LAYOUT PLANS

5. Prior to the commencement of construction, the Applicant must submit detailed plans of the final layout of the development to the Secretary, including details on the siting of solar panels and ancillary infrastructure.

Note: If the construction of the development is to be staged, then the provision of these plans may be staged.

UPGRADING OF SOLAR PANELS AND ANCILLARY INFRASTRUCTURE

6. Over time, the Applicant may upgrade the solar panels and ancillary infrastructure on site provided these upgrades remain within the approved development footprint of the site. Prior to carrying out any such upgrades, the Applicant must provide revised layout plans of the development to the Secretary incorporating the proposed upgrades.

WORK AS EXECUTED PLANS

7. Prior to the commencement of operations or following the upgrades of any solar panels or ancillary infrastructure, the Applicant must submit work as executed plans of the development to the Department.

NOTIFICATION OF WORKS

8. Prior to the commencement of construction, operations, upgrading or decommissioning of the development or the cessation of operations, the Applicant must notify the Department in writing of the date of commencement, or cessation, of the relevant phase.

If any of these phases of the development are to be staged, then the Applicant must notify the Department in writing prior to the commencement of the relevant stage, and clearly identify the development that would be carried out during the relevant stage.

STRUCTURAL ADEQUACY

9. The Applicant must ensure that all new buildings and structures, and any alterations or additions to existing buildings and structures, are constructed in accordance with the relevant requirements of the *Building Code of Australia*.

Notes:

- Under Part 4A of the EP&A Act, the Applicant is required to obtain construction and occupation certificates for the proposed building works.
- Part 8 of the EP&A Regulation sets out the requirements for the certification of the development.

DEMOLITION

10. The Applicant must ensure that all demolition work on site is carried out in accordance with *Australian Standard AS 2601-2001: The Demolition of Structures*, or its latest version.

PROTECTION OF PUBLIC INFRASTRUCTURE

- 11. Unless the Applicant and the applicable authority agree otherwise, the Applicant must:
 - (a) repair, or pay the full costs associated with repairing, any public infrastructure that is damaged by the development; and
 - (b) relocate, or pay the full costs associated with relocating, any public infrastructure that needs to be relocated as a result of the development.

This condition does not apply to the upgrade and maintenance of the road network, which is expressly provided for in the conditions of this consent.

OPERATION OF PLANT AND EQUIPMENT

- 12. The Applicant must ensure that all plant and equipment used on site, or in connection with the development, is:
 - (a) maintained in a proper and efficient condition; and
 - (b) operated in a proper and efficient manner.

SCHEDULE 3 ENVIRONMENTAL CONDITIONS – GENERAL

TRANSPORT

Heavy Vehicle Restrictions

- 1. The Applicant must ensure that the:
 - (a) development does not generate more than:
 - 30 heavy vehicle movements a day during construction, upgrading or decommissioning; or
 - 5 heavy vehicle movements a day during operations;

 a the public read networks and
 - on the public road network; and
 - (b) length of any vehicles used for the development does not exceed 25 metres; unless the Secretary agrees otherwise.
- 2. The Applicant must keep accurate records of the number of heavy vehicles entering or leaving the site each day.

Access Route

3. All vehicular traffic associated with the development must travel to and from the project site via the Castlereagh Highway, Beryl Road and the approved site entry point off Beryl Road (shown in Appendix 1).

Road Upgrades

- 4. Prior to the commencement of construction, the Applicant must:
 - (a) upgrade the intersection of the Castlereagh Highway and Beryl Road to provide, as a minimum, a Channelised Right (CHR) turn lane and Auxiliary Left (AUL) turn lane to the satisfaction of RMS, and in accordance with the Austroads Guide to Road Design (as amended by RMS supplements), unless RMS agrees otherwise; and
 - (b) upgrade Beryl Road between the Castlereagh Highway and the project site access point to allow two-way construction traffic, including:
 - sealing the road a minimum of 30 metres from the edge of the Castlereagh Highway travel lane;
 - paving and widening of the road shoulders to 1.5 metres on either side; and
 - line-marking on the centre line and edge lines of the road;

to the satisfaction of RMS and Council.

Site Access

5. Prior to the commencement of construction, the Applicant must construct one site entry point off Beryl Road (shown in Appendix 1) to the satisfaction of Council and in accordance with Council's relevant guidelines.

Operating Conditions

- 6. The Applicant must ensure:
 - (a) the internal roads are constructed as all-weather roads:
 - (b) there is sufficient parking on site for all vehicles, and no parking occurs on the public road network in the vicinity of the site:
 - (c) all vehicles are loaded and unloaded on site; and
 - (d) vehicles leaving the site are in a clean condition and do not result in dirt being tracked onto the public road network.

Unformed Crown Roads

7. The Applicant must ensure any unformed Crown road reserves affected by the development are maintained for future use, unless otherwise agreed with the Department of Industry – Lands & Forestry.

Traffic Management Plan

- 8. Prior to the commencement of any road upgrades required under this consent, the Applicant must prepare a Traffic Management Plan for the development to the satisfaction of the Secretary. This plan must be prepared in consultation with the RMS and Council, and include:
 - (a) details of the entire transport route to be used for development-related traffic;
 - (b) the origin, destination, number, loads, weights and lengths, frequency, including peak and daily traffic volumes and destination of vehicles accessing/exiting the site;
 - (c) a protocol for undertaking dilapidation surveys to assess the:
 - existing condition of Beryl Road prior to construction, upgrading or decommissioning activities;
 and
 - condition of Beryl Road following construction, upgrading or decommissioning activities;
 - (d) a protocol for the repair of any roads identified in the dilapidation surveys to have been damaged during construction, upgrading or decommissioning works;
 - (e) details of the measures that would be implemented to minimise traffic safety issues and disruption to local users of the transport route during construction, upgrading or decommissioning works, including:
 - temporary traffic controls, including detours and signage;
 - notifying the local community about project-related traffic impacts;
 - minimising potential for conflict with school buses and other motorists as far as practicable;
 - scheduling of haulage vehicle movements to minimise convoy length or platoons;
 - minimising vehicles entering and leaving the site in a backward direction as far as practicable;
 - responding to local climate conditions that may affect road safety such as fog, dust, wet weather; and
 - · responding to any emergency repair or maintenance requirements;
 - (f) a driver's code of conduct that addresses:
 - · travelling speeds;
 - · driver fatigue;
 - · procedures to ensure that drivers adhere to the designated transport routes; and
 - procedures to ensure that drivers implement safe driving practices.

Following the Secretary's approval, the Applicant must implement the Traffic Management Plan.

LANDSCAPING

Visual Impact Mitigation Measures

9. For a period of 3 years from the commencement of construction, the owner of Lot 59 DP755434 may ask the Applicant to implement visual impact mitigation measures on their land to minimise the visual impacts of the development on their residence (including its curtilage).

Upon receiving such a written request from the owner, the Applicant must implement appropriate mitigation measures (such as landscaping and vegetation screening) in consultation with the owner.

These mitigation measures must be reasonable and feasible, aimed at reducing the visibility of the solar panels and ancillary infrastructure from the residence and its curtilage, and commensurate with the level of visual impact on the residence.

All mitigation measures must be implemented within 12 months of receiving the written request, unless the Secretary agrees otherwise.

Notes

- To avoid any doubt, mitigation measures are not required to be implemented to reduce the visibility of the solar
 panels and ancillary infrastructure from any other locations on the property other than the residence and its
 curtilage.
- 10. The Applicant must establish and maintain a mature vegetation buffer around the site at the locations outlined in the figure in Appendix 1, to the satisfaction of the Secretary. These measures must:
 - (a) be planted prior to the commencement of operations;
 - (b) consist of vegetation species that facilitate the best possible outcome in terms of visual screening;
 - (c) be effective at screening views of the solar panels and ancillary infrastructure on site from surrounding residences within 3 years of the commencement of construction; and
 - (d) be properly maintained and kept free of weeds.

Landscaping Plan

- 11. Prior to the commencement of construction, the Applicant must prepare a detailed Landscaping Plan for the planting within the vegetation buffer in consultation with BCS and Council, to the satisfaction of the Secretary. The plan must:
 - (a) include a description of measures that would be implemented to ensure that the vegetated buffer achieves the objectives of Schedule 3 condition 10 (b) (d) of this consent;
 - (b) include a program to monitor and report on the effectiveness of these measures; and
 - (c) include details of who would be responsible for monitoring, reviewing and implementing the plan, and timeframes for completion of actions.

Following the Secretary's approval, the Applicant must implement the Landscaping Plan.

LAND MANAGEMENT

- 12. Following any construction or upgrading on site, the Applicant must:
 - (a) restore the ground cover of the site as soon as practicable, using suitable species;
 - (b) maintain ground cover; and
 - (c) keep this ground cover free of weeds.

BIODIVERSITY

Retirement of Credits

13. Within three years of commencing development under this consent, unless otherwise agreed by the Secretary, the Applicant must retire biodiversity credits of a number and class specified in Table 1 below to the satisfaction of BCS.

The retirement of these credits must be carried out in accordance with the NSW Biodiversity Offsets Policy for Major Projects, and can be achieved by:

- (a) acquiring or retiring credits under the Biobanking Scheme in the *Threatened Species Conservation*Act 1995:
- (b) making payments into an offset fund that has been developed by the NSW Government; or
- (c) providing supplementary measures.

14. The Applicant must not use any land zoned R5 – Large Lot Residential on Lot 20 DP 1173059 as an offset to retire the required biodiversity credits specified in Table 1.

Note: To identify the land zones, see the figure in Appendix 1.

BIODIVERSITY MANAGEMENT PLAN

- 15. Prior to the commencement of construction, the Applicant must prepare a Biodiversity Management Plan for the development in consultation with BCS, to the satisfaction of the Secretary. This plan must:
 - (a) include a description of the measures that would be implemented for:
 - · managing the remnant vegetation and fauna habitat on site;
 - minimising clearing and avoiding unnecessary disturbance associated with the construction and operation of the development;
 - minimising the impacts to fauna on site (including fauna interaction with perimeter fencing) and implementing fauna management protocols;
 - rehabilitating and revegetating temporary disturbance areas;
 - protecting vegetation and fauna habitat outside the approved disturbance areas;
 - maximising the salvage of vegetative and soil resources within the approved disturbance area for beneficial reuse in the enhancement of the offset area or the rehabilitation of the site;
 - · controlling weeds and feral pests;

- (b) include a seasonally-based program to monitor and report on the effectiveness of these measures;
- (c) include details of who would be responsible for monitoring, reviewing and implementing the plan, and timeframes for completion of actions.

Following the Secretary's approval, the Applicant must implement the Biodiversity Management Plan.

Note: If the biodiversity offset area is conserved via a Biobanking Agreement, then the Biodiversity Management Plan does not need to include any of the matters that are covered under the Biobanking Agreement.

AMENITY

Construction, Upgrading and Decommissioning Hours

- 16. Unless the Secretary agrees otherwise, the Applicant must only undertake construction, upgrading or decommissioning activities on site between:
 - (a) 7 am to 6 pm Monday to Friday;
 - (b) 8 am to 1 pm Saturdays; and
 - (c) at no time on Sundays and NSW public holidays.

The following construction, upgrading or decommissioning activities may be undertaken outside these hours without the approval of the Secretary:

- the delivery of materials as requested by the NSW Police Force or other authorities for safety reasons;
 or
- emergency work to avoid the loss of life, property and/or material harm to the environment.

Noise

17. The Applicant must minimise the noise generated by any construction, upgrading or decommissioning activities on site in accordance with the best practice requirements outlined in the *Interim Construction Noise Guideline* (DECC, 2009), or its latest version.

Dust

18. The Applicant must minimise the dust generated by the development.

Visual

- 19. The Applicant must:
 - (a) minimise the off-site visual impacts of the development, including the potential for any glare or reflection from the solar panels;
 - (b) ensure the visual appearance of all ancillary infrastructure (including paint colours) blends in as far as possible with the surrounding landscape; and
 - (c) not mount any advertising signs or logos on site, except where this is required for safety purposes.

Lighting

- 20. The Applicant must:
 - (a) minimise the off-site lighting impacts of the development, including the potential for any glint, glare or reflection from the solar panels; and
 - (b) ensure that all external lighting associated with the development:
 - is installed as low intensity lighting (except where required for safety or emergency purposes);
 - · does not shine above the horizontal; and
 - complies with Australian Standard AS4282 (INT) 1997 Control of Obtrusive Effects of Outdoor Lighting, or its latest version.

HERITAGE

Discovery of Human Remains

21. If human remains are discovered on site, then all work surrounding the area must cease, and the area must be secured. The Applicant must notify the NSW Police and Heritage NSW as soon as possible

following the discovery, and work must not recommence in the area until this is authorised by Heritage NSW.

Chance Finds Protocol

22. Prior to commencement of construction, the Applicant must prepare a Chance Finds Protocol for the development in consultation with the Aboriginal Stakeholders, and to the satisfaction of Heritage NSW.

Following Heritage NSW's approval, the Applicant must implement the Chance Finds Protocol.

Operating Conditions

23. Prior to the commencement of construction, the Applicant must salvage and relocate Aboriginal heritage items Beryl Solar Farm IF1, Beryl Solar Farm IF2, Beryl Solar Farm IF3, Beryl Solar Farm IF4 and Beryl Solar Farm AS 1, to suitable alternative locations on the site, in accordance with the *Code of Practice for Archaeological Investigation of Aboriginal Objects in NSW* (DECCW, 2010), or its latest version.

Note: The locations of the Aboriginal heritage items referred to in this condition are shown in the figure in Appendix 1.

SOIL AND WATER

Water Pollution

24. The Applicant must ensure that the development does not cause any water pollution, as defined under Section 120 of the *Protection of the Environment Operations Act 1997*.

Operating Conditions

- 25. The Applicant must:
 - (a) ensure the solar panels and associated infrastructure are designed, constructed and maintained to avoid causing any tunnel erosion on site;
 - (b) minimise any soil erosion associated with the construction, upgrading or decommissioning of the development in accordance with the relevant requirements in the *Managing Urban Stormwater: Soils and Construction* (Landcom, 2004) manual, or its latest version; and
 - (c) ensure all waterway crossings are constructed in accordance with the:
 - Water Guidelines for Controlled Activities on Waterfront Land (2012), or its latest version; and
 - Why Do Fish Need to Cross the Road? Fish Passage Requirements for Waterway Crossings (2004), or its latest version.

HAZARDS

Storage and Handling of Dangerous Goods

- 26. The Applicant must:
 - (a) store and handle all dangerous or hazardous materials on site in accordance with AS1940-2004: The storage and handling of flammable and combustible liquids, or its latest version;
 - (b) ensure the substation is suitably bunded; and
 - (c) minimise any spills of hazardous materials or hydrocarbons, and clean up any spills as soon as possible after they occur.

Operating Conditions

- 27. The Applicant must:
 - (a) minimise the fire risks of the development;
 - (b) ensure that the development:
 - complies with the relevant asset protection requirements in the RFS's *Planning for Bushfire Protection 2006* (or equivalent);
 - is suitably equipped to respond to any fires on site;
 - (c) assist the RFS and emergency services as much as practicable if there is a fire in the vicinity of the site: and
 - (d) notify the relevant local emergency management committee following construction of the development, and prior to the commencement of operations.

Emergency Response Plan

28. Prior to the commencement of operations, the Applicant must prepare an Emergency Response Plan for the development in consultation with the RFS and Fire & Rescue NSW. This plan must identify the fire risks and controls of the development, and the procedures that would be implemented if there is a fire on site or in the vicinity of the site. Two copies of the plan must be kept on site in a prominent position adjacent to the site entry point at all times.

WASTE

- 29. The Applicant must:
 - (a) minimise the waste generated by the development;
 - (b) classify all waste generated on site in accordance with the EPA's Waste Classification Guidelines 2014 (or its latest version);
 - (c) store and handle all waste on site in accordance with its classification;
 - (d) not receive or dispose of any waste on site; and
 - (e) remove all waste from the site as soon as practicable, and ensure it is sent to an appropriately licensed waste facility for disposal.

DECOMMISSIONING AND REHABILITATION

30. Within 18 months of the cessation of operations, unless the Secretary agrees otherwise, the Applicant shall rehabilitate the site to the satisfaction of the Secretary. This rehabilitation must comply with the objectives in Table 2.

SCHEDULE 4 ENVIRONMENTAL MANAGEMENT AND REPORTING

ENVIRONMENTAL MANAGEMENT

Environmental Management Strategy

- 1. Prior to the commencement of construction, the Applicant must prepare an Environmental Management Strategy for the development to the satisfaction of the Secretary. This strategy must:
 - (a) provide the strategic framework for environmental management of the development;
 - (b) identify the statutory approvals that apply to the development;
 - (c) describe the role, responsibility, authority and accountability of all key personnel involved in the environmental management of the development;
 - (d) describe the procedures that would be implemented to:
 - keep the local community and relevant agencies informed about the operation and environmental performance of the development;
 - · receive, handle, respond to, and record complaints;
 - resolve any disputes that may arise;
 - respond to any non-compliance;
 - · respond to emergencies; and
 - (e) include:
 - · copies of any plans approved under the conditions of this consent; and
 - a clear plan depicting all the monitoring to be carried out in relation to the development.

Following the Secretary's approval, the Applicant must implement the Environmental Management Strategy.

Revision of Strategies and Plans

- 2. The Applicant must:
 - (a) update the strategies and plans required under this consent to the satisfaction of the Secretary prior to carrying out any upgrading or decommissioning activities on site; and
 - (b) review and, if necessary, revise the strategies and plans required under this consent to the satisfaction of the Secretary within 1 month of the:
 - submission of an incident report under condition 3 below; or
 - any modification to the conditions of consent.

INCIDENT NOTIFICATION

3. The Department must be notified in writing via the Major Projects website portal immediately after the Applicant becomes aware of an incident. The notification must identify the development (including the development application number and the name of the development if it has one), and set out the location and nature of the incident.

NON-COMPLIANCE NOTIFICATION

4. The Department must be notified in writing via the Major Projects website portal within 7 days after the Applicant becomes aware of any non-compliance with the conditions of this consent.

The notification must identify the development and the application number for it, set out the condition of consent that the development is non-compliant with, the way in which it does not comply and the reasons for the non-compliance (if known) and what actions have been done, or will be, undertaken to address the non-compliance.

INDEPENDENT ENVIRONMENTAL AUDIT

- 5. Within 6 months of the commencement of construction, or as directed by the Secretary, the Applicant must commission and pay the full cost of an Independent Environmental Audit (Audit) of the development. The audits must:
 - (a) be led and conducted by a suitably qualified, experienced and independent team of experts whose appointment has been endorsed by the Secretary;
 - (b) be carried out in consultation with the relevant agencies;
 - (c) assess whether the development complies with the relevant requirements in this consent, and any strategy, plan or program required under this consent; and
 - (d) recommend appropriate measures or actions to improve the environmental performance of the development and any strategy, plan or program required under this consent.


Within 3 months of commencing an Independent Environmental Audit, or unless otherwise agreed by the Secretary, a copy of the audit report must be submitted to the Secretary, and any other NSW agency that requests it, together with a response to any recommendations contained in the audit report, and a timetable for the implementation of the recommendations.

The recommendations must be implemented to the satisfaction of the Secretary.

ACCESS TO INFORMATION

- 6. The Applicant must:
 - (a) make the following information publicly available on its website as relevant to the stage of the development:
 - the EIS:
 - the final layout plans for the development;
 - current statutory approvals for the development;
 - the proposed staging plans for the development if the construction, operation or decommissioning of the development is to be staged;
 - how complaints about the development can be made;
 - a complaints register:
 - any other matter required by the Secretary; and
 - (b) keep this information up to date.
