Description of amended proposal

The State significant development (SSD) application, as amended, seeks approval for demolition and construction of a ten-storey residential flat building, including in-fill affordable housing, comprising:

- 120 dwellings (including 27 in-fill affordable housing apartments and 3 affordable housing apartments in perpetuity)
 - basement parking for 184 cars
 - communal open space at ground level and levels 8 and 9
 - associated works including site preparation, demolition, tree removal, excavation, earthworks, landscaping and infrastructure works.
