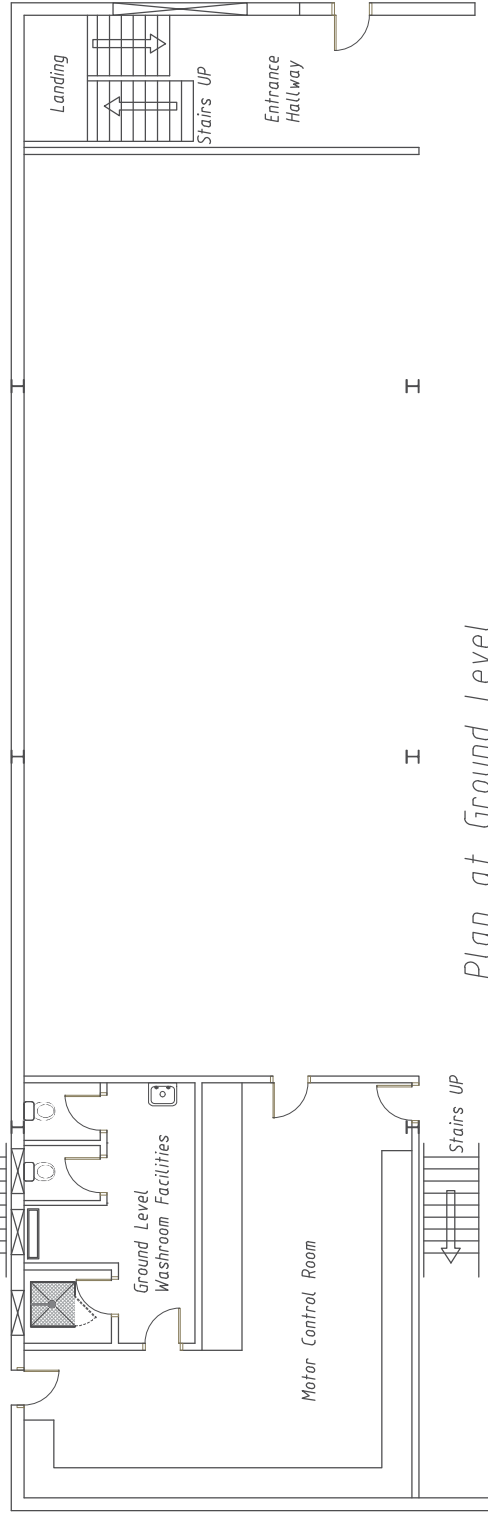


Plan at First Floor Level
