Re: Endorsement request of suitably qualified and experienced persons for Noise Management Plan (NMP) preparation – SSD 8642

On 26 April 2021 the Independent Planning Commission (IPC) approved the Mangoola Coal Continued Operations (MCCO) Project under Part 4 of the *Environmental Planning and Assessment Act* 1979 and issued Development Consent for State Significant Development (SSD) 8642. Condition B8(a) of SSD 8642 states:

B8. The Applicant must prepare a Noise Management Plan for the development to the satisfaction of the Planning Secretary. The plan must:

(a) be prepared by suitably qualified and experienced person/s whose appointment has been endorsed by the Planning Secretary;
