## ***Surrender of PA 06\_0014***

In accordance with Condition A15 of SSD 8642, Mangoola Coal Operations Pty Limited, the holder of development consent PA 06\_0014 hereby gives notice of the surrender of that consent (PA 06\_0014).

Notice is made subject to the provisions of Clause 67(2) of the *Environmental Planning and Assessment Regulation 2021*. The requirements and responses relative to this clause, are as follows:

**a) the name and address of the person giving the notice:**

Mangoola Coal Operations Pty Limited.

**b) the address and folio identifier of the land to which the consent or right relates:**

The land to which the consent or right relates are in the schedules of land found in Appendix 1 of:

- PA 06\_0014 Mod 2 (MP06\_0014-Mod-2),

- PA 06\_0014 Mod 4 (MP06\_0014-Mod-4),
- PA 06\_0014 Mod 5 (MP06\_0014-Mod-5),
- PA 06\_0014 Mod 6 (MP06\_0014-Mod-6),
- PA 06\_0014 Mod 7 (MP06\_0014-Mod-7),
- PA 06\_0014 Mod 8 (MP06\_0014-Mod-8).

**c) a description of the consent or right to be modified or surrendered:**

Project Approval 06\_0014 (PA 06\_0014) was granted in June 2007 for the construction of an open cut coal mine and associated infrastructure in the Wybong area, known as the Anvil Hill Project. The proponent at the time was Centennial Hunter Pty Ltd (owned by Centennial Coal). The approved Project was later purchased by Mangoola Coal Operations Pty Ltd and renamed Mangoola Open Cut (Mangoola). The original approval included extraction up to 10.5 million tonnes per annum (Mtpa) of run-of-mine (ROM) coal. The original approval has been modified multiple (eight) times to include various matters such as an increase in annual extraction of up to 13.5 Mtpa ROM coal. The approval also covers a Coal Handling and Preparation Plant (CHPP) and Train Loading Facility.

Mangoola is located near Wybong, New South Wales (NSW), approximately 20 kilometres (km) west of Muswellbrook and approximately 10 km north of Denman in the Muswellbrook Local Government Area (LGA).

The right to surrender is granted Condition A15 of SSD 8642. SSD 8642 currently prevails over PA 06\_0014 and will continue to act as the Development Consent for Mangoola Open Cut operations.

**d) whether the consent or right will be modified, including details of the modification, or surrendered,**

PA 06\_0014 will be **surrendered** as required by Condition A15 of SSD 8642 and in accordance with Clause 67 of the *Environmental Planning and Assessment Regulation 2021*.

**e) if the person giving the notice is not the owner of the land—a statement signed by the owner of the land that the owner consents to the modification or surrender of the consent or right.**

This clause should be read in conjunction with cl 67 (5) - *The consent of the owner is not required under subsection (2)(e) if the consent of the owner of the land was not required under section 23 to make the application for the development consent.*

At the time of the development application relative to PA 06\_0014, landowner consent was not required pursuant to Schedule 1 Division 2 cl14 of the Mining Act 1992 (in force at the time of application). As such, cl 67(2)(e) is not applicable to this notice of surrender.
