1. In the table of DEFINITIONS of Schedule 1, delete the definition for 'EIS' and insert the following:

- *Jemalong Hybrid Solar Park Response to Submissions Report* (NGH Environmental Pty Ltd, 14 February 2018);
- the Applicant's letter dated 5th April 2018;
- *Jemalong Hybrid Solar Park Modification Application* (NGH Environmental Pty Ltd, 15 June 2018); and
- the Applicant's letters dated 2nd and 12th July 2018.

2. In Schedule 2, after condition 12, add the following condition:

SUBDIVISION

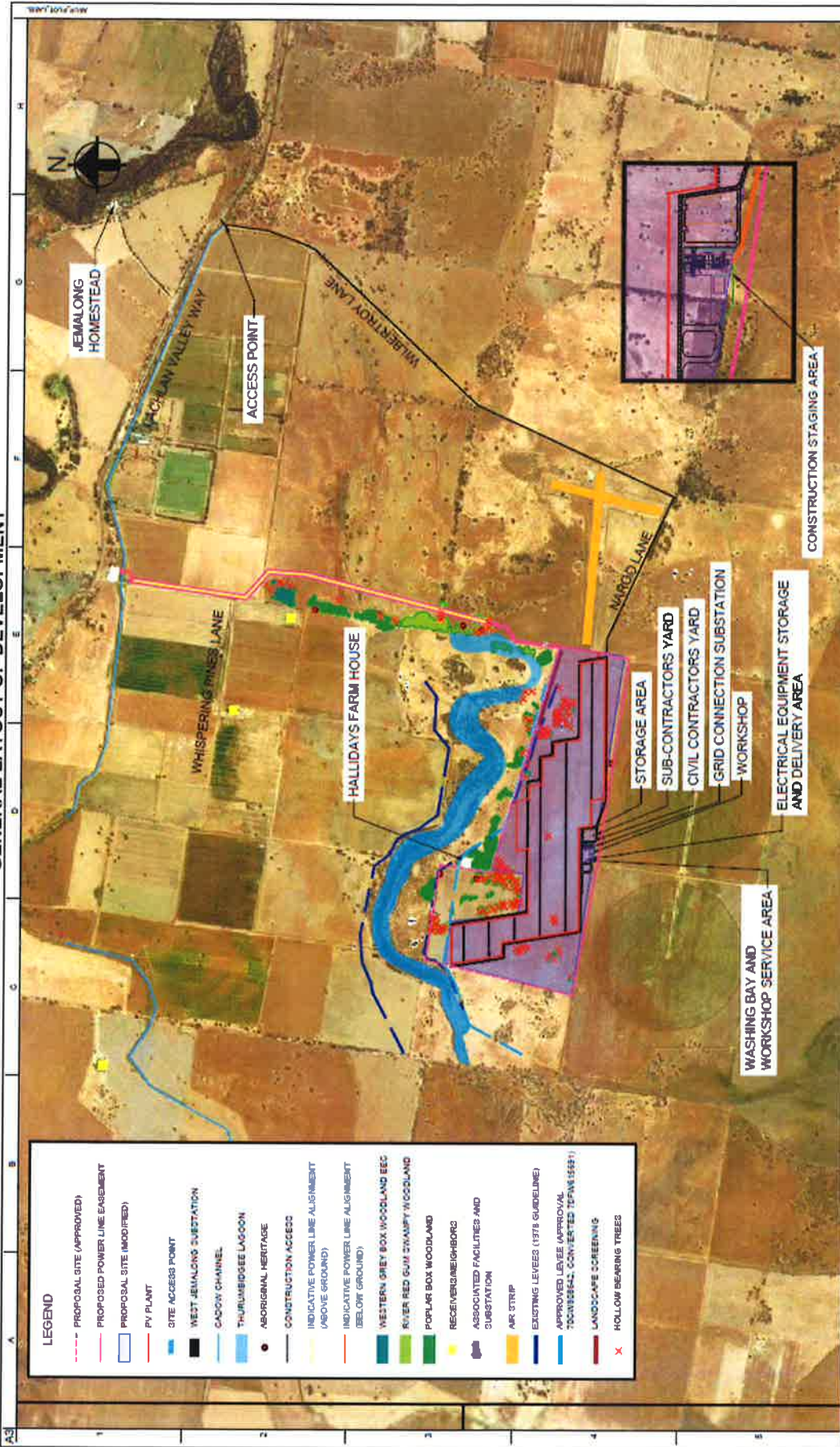
13. The Applicant may subdivide Lot 13 DP753116 to create two additional allotments, in accordance with the EIS and the requirements of the EP&A Act and EP&A Regulation.

Notes:

- Part 8 of the EP&A Regulation sets out the application requirements for subdivision certificates.
