**Loreto Normanhurst School Redevelopment (SSD 8996)  
Landscape and Architectural Plans, Schedule 3, Conditions B2, B3, B4, B5, B18, D20**

I refer to the Landscape and Architectural Plans submitted to the Planning Secretary in accordance with conditions B2, B3, B4, B5, B18, and D20 of SSD 8996. I also acknowledge and thank you for your response to the Department's review comments and request for additional information.

I note that the updated Landscape and Architectural Plans:

- have been reviewed by the Applicant and no issues have been raised;
- relate to the design amendments (conditions B2 and B3), electrical substation (condition B4), landscape plans (condition B5), bicycle parking (condition B18) and tree hollows and nest boxes (condition D20) of the consent; and
- have been submitted to the Department prior to undertaking any construction works.
