Hope you are well.

We are coming back to Narrandera Shire Council again to seek a further extension of our vehicle movements and size for the Avonlie Solar Farm.

Our latest approval of 26m B-Doubles, 50 Movements & 24 OSOM loads expires on the 11<sup>th</sup> of August 2022.

What we are seeking is the departments to accept the following going forward:

- Allowance for 26m B-Doubles for the remainder of the permit (from the 19m condition in the original consent)
- The maximum heavy vehicle movements can reduce to the origin conditions of consent which are 35 movements (from the 50 approved in the extension)
- The number of over-dimensional vehicle movements to go to 21 (24 were approved previously in the last extension with 3 of the movements having been undertaken by August the 11<sup>th</sup> when the extension to the conditions runs out)

Thank you for engaging with Council about the proposed modification to increasing the amount of currently approved vehicle movements and size of trucks to deliver the solar farm. Council has now reviewed the request and provide the comments below.

The Sandigo / Sturt intersection as already a gazetted b-double route, therefore the only intersection in question is the Muntz/Sandigo intersection.

The previous modification caused no concern or problems for council, especially given the additional works of sealing Muntz Road at the developers cost. Given the previous experience and road conditions, I have no objection to the nominated change in vehicle type, mass or volume as described in the request.

Good morning Shane,

As discussed, Iberdrola project-owner of the Avonlie Solar Farm are seeking Narrandera Shire Council's feedback on increasing the amount of currently approved vehicle movements and size of trucks to deliver the solar farm.

The project currently has approved 35 movements per day with 19m vehicles and 3 over dimensional loads throughout construction. The previous approval to increase these numbers, expired earlier this week.

Therefore, Iberdrola is seeking approval for an increase in heavy vehicle and over-dimensional vehicle movements and the maximum length of vehicles beyond 24 May 2022 under Schedule 3 CoA 2 (a) and (b). This would allow:

- a. the number of heavy vehicles a day to increase from 35 to 50 between 25 May 2022 and 30 July 2022 inclusive;
- b. the number of over-dimensional vehicle movements to increase from 3 to 24 for the duration of the project;

- c. the length of vehicles used for the development (excluding over-dimensional vehicles) to increase from 19 m to 26 m for the duration of the project.

A Traffic Analysis has been undertaken (see attached). These increases will likely have minimal impact to the operation of the surrounding road network.

If you could you please review and provide any feedback, that would be greatly appreciated.
