Wagga Wagga Base Hospital: Baseline Archaeological Assessment - Addendum

Dear Dan,

As per your request, I have prepared this letter as an addendum to the Baseline Archaeological Assessment (2012), prepared by Archaeological and Heritage Management Solutions (AHMS), for the property known as Wagga Wagga Base Hospital at Docker and Edward Streets, Wagga Wagga, NSW (the study area).

This addendum provides an updated search of the Aboriginal Heritage Information Management System (AHIMS), a database of known and registered Aboriginal sites in NSW. The AHIMS database is managed and maintained by the Office of Environment and Heritage, and search results of the database remain valid for a period of 12 months. As this period has expired, a new search was conducted, and the results and updated recommendations are outlined below. It is to be stressed that this document and the original report should be read in conjunction.

The original search of the AHIMS database was undertaken on 1 September 2009, and returned no sites listed in the study area (AHIMS ID 27119). The updated search was carried out on 22 October 2018, covering a radius of 5km around the study area (AHIMS ID 377643). No registered sites were listed in the area as per the updated search. A copy of the results is attached.

As no sites were returned in the updated AHIMS search, the original recommendations made in the Baseline Archaeological Assessment (AHMS 2012) remain valid.
