SCHEDULE 1

Development consent:	SSD 9211 granted by the Executive Director, Priority Projects Assessments on 12 December 2018.
For the following:	Construction of a new two storey acute clinical services building, on-grade car parking and drop-off facilities, upgrades to IT and engineering services infrastructure, non-clinical support services within the proposed new building, associated landscaping works and demolition of vacant buildings.

Modification:	SSD 9211 MOD 3: Insertion of a staging conditions to enable construction works to occur concurrently across stages.

SCHEDULE 2

The consent (SSD 9211) is modified as follows:

- a) Schedule 2 – Part A Administrative Conditions is amended by the insertion of the **bold and underlined** words/numbers, immediately following condition A20 as follows:

Staging

A21. The project may be constructed and operated in stages. Where staged construction or operation is proposed (to the extent to which it relates to the requirements set out in this instrument), a Staging Report (for either or both construction and operation as the case may be) must be prepared and submitted for the approval of the Planning Secretary.

A22. A Staging Report prepared in accordance with condition A21 must:

- (a) if staged construction is proposed, set out how the construction of the whole of the project will be staged, including details of work and other activities to be carried out in each stage and the general timing of when construction of each stage will commence and finish;**
- (b) if staged operation is proposed, set out how the operation of the whole of the project will be staged, including details of work and other activities to be carried out in each stage and the general timing of when operation of each stage will commence and finish (if relevant);**
- (c) specify how compliance with conditions will be achieved across and between each of the stages of the project; and**
- (d) set out mechanisms for managing any cumulative impacts arising from the proposed staging.**

A23. Where staging is proposed, the project must be staged in accordance with the Staging Report, as approved by the Planning Secretary.

A24. Where staging is proposed, the terms of this approval that apply or are relevant to the works or activities to be carried out in a specific stage must be complied with at the relevant time for that stage.
